

THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

BY-LAW NO. 92-26

A By-law for the disposal of garbage in the Township of Westmeath

WHEREAS:

- A. The Municipal Act 1990 R.S.O. Chapter M45 Section 210, subsection 89 authorizes a municipality to pass by-laws for establishing and maintaining a system for the collection and removal of garbage and other refuse upon such terms and conditions as may be considered expedient; and
- B. The Municipal Act 1990 R.S.O. Chapter M45 Section 210, Subsection 82, authorizes the municipality to prohibit the depositing of refuse or debris on the property of the municipality without the authority of the owner of such property.
- C. The Municipal Act 1990 R.S.O. Chapter M45 Section 320 authorizing the municipality to provide in its by-laws penalties for the contravention of its by-laws.

WHEREAS:

1. The Council for the Corporation of the Township of Westmeath wishes to extend the life of its garbage and refuse disposal site in the Township of Westmeath by limiting the amount of garbage and refuse disposed therein by the residents of the Township; and
2. It is necessary to enforce a system at the Garbage Disposal Site for the orderly separation and disposal of various types of garbage and refuse so as to facilitate disposal and limit infilling; and
3. It is necessary to impose surcharges for the disposal of garbage and refuse at the Westmeath Garbage Site to offset the cost of the supervision and operation thereof.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WESTMEATH ENACTS AS FOLLOWS:-

1. All garbage and refuse entering the Westmeath Township Municipal Landfill Site for disposal therein, other than the following items, shall be contained in specially marked yellow (W) garbage bags available from the Township of Westmeath for a fee of \$3.00 (Three Dollars):

- (i) raw wood and brush
- (ii) metal items
- (iii) tires
- (iv) construction debris (excluding items otherwise set forth in this section)
- (v) furniture
- (vi) household appliances
- (vii) yard and garden accessories
- (viii) plumbing related fixtures (bathroom, kitchen)
- (ix) masonry waste
- (x) styrofoam and other forms of insulation and packaging
- (xi) canvas and other large plastic coverings
- (xii) toys

2. The above mentioned specifically defined items of Waste (i) to (xii) shall be permitted to enter the Westmeath Waste Disposal Site provided they are segregated by type, are clearly visible to the attendant and payment of the following tipping fee is made:

- (a) clean wood and brush shall be accepted with no charge.
- (b) metal items - no charge, excepting specific "white" articles such as hot water tanks, refrigerators, electric stoves, dishwashers, clothes dryers, clothes washers, deep freezers, and other such items which require special disposal, which items shall incur a disposal fee of \$5.00 per item;
- (c) tires as per Schedule 'A' hereby attached;
- (d) all other items not specified above namely, construction debris, furniture, appliances, yard and garden accessories, plumbing fixtures, styrofoam and other forms of insulation, packaging, canvas, plastic and toys may be disposed in truck load quantities. Tipping fees shall be \$ 4.00 per car trunk or for a small trailer load, \$ 8.00 per half ton truck load, \$ 75.00 per large truck or dumpster load and \$ 150.00 per compactor truck load.

3. No person shall dispose of any waste at the Westmeath Disposal Site in the absence of the attendant or without the specific authorization of the attendant. Any person who disposes of waste at the Westmeath Disposal Site, without receiving the specific authorization of the attendant, shall be guilty of an offence and subject to a fine of \$ 300.00 for the first offence and a fine of \$ 1,000.00 for all subsequent offences.

Passenger/Light Truck Tires	\$ 3.00	add \$ 2.00
Heavy Truck Tires	\$ 15.00	add \$ 15.00
Tractor Tires - Front	\$ 5.00	add \$ 25.00
Tractor Tires - Rear	\$ 25.00	add \$ 25.00
Tractor Tires - Over 6 ft. diameter	\$ 45.00	add \$ 25.00
