A By-Law to enter into an Agreement for Removal of Metals at the Landfill Site.

WHEREAS:

 The Municipality has authority under Section 210(89) Chapter M. 45 of the Municipal Act RSO 1990 to pass a by-law to establish and maintain a system for the collection, removal and disposal of garbage.

AND WHEREAS:

2. The Council of the Corporation of the Township of Westmeath intends to enter into an agreement with a private contractor for removal of metals from the landfill site.

Now THEREFORE the Council of the Corporation of the Township of Westmeath ENACTS as follows:-

- <u>1</u> The Reeve and Clerk are hereby authorized to sign an agreement with Kenyon Auto Centre to remove metals from the landfill site.
- <u>2</u> The Agreement mentioned in Clause <u>1</u> shall be known as Schedule "A" and forms part of this by-law.
- <u>3</u> The term of the contract shall be from October 1st, 1993 to September 30th, 1998.

AGREEMENT BETWEEN

KENYON AUTO CENTRE

AND

CORPORATION OF THE TOWNSHIP OF WESTMEATH

- Kenyon Auto Centre will be the sole remover of all metals brought to the landfill site over a five year period (metals will not include tires, wood, any toxic compound (element) or environmentally hazardous material).
- 2. The material will be picked up at least twice a year (more if necessary) at a location at the landfill site accessible to a tractor trailer. First pick-up to be October 1993.
- 3. "White Goods" such as stoves, washers, dryers, fridges and freezers will be included as metals.
- 4. There is to be no money paid for either the service or the material except if the landfill site attendant allows some of the material to go to a third party in which case the Township will pay Kenyon Auto Centre to remove the material left at a rate normally in effect at the time.
- 5. Kenyon Auto Centre will contact the Westmeath Municipal Office at least one day ahead of arrival to arrange for the key to the landfill site. A representative of Kenyon Auto Centre will come to the Municipal Office and sign for and pick up the key to the landfill site. Kenyon Auto Centre will be responsible for keeping the gate locked while loading metals and return the key to the Municipal Office after completion of pick-up.
- 6. Kenyon Auto Centre will agree to pick up tires at the following rates: tractor tires \$10.00 each, truck tires \$5.00 each, and car tires \$2.00 each.
- 7. Westmeath Township agree to have the material rolled over by a bulldozer or loader at the Township's expense.
- 8. This agreement can be terminated by either party with 30 days written notice. No reason need be given. Otherwise this agreement shall be for a five year term.
