A By-Law to enter into an agreement with Bernard and Marie Zettler regarding restricting future severances.

WHEREAS:

- 1. The Council of the Corporation of the Township of Westmeath has authority under Section 102 of the Municipal Act, R.S.O. 1990 to pass By-Laws concerning the welfare of the inhabitants of the Municipality.
- 2. The Council of the Corporation of the Township of Westmeath has authority under Section 51(6) and 53(2) of the Planning Act, R.S.O. 1990 to enter into agreements with an owner of land as a condition of the approval of subdivision of land.
- 3. The Renfrew County Land Division Committee requires the landowners to enter into an agreement with the Township restricting future severances.

NOW THEREFORE the Council of the Corporation of the Township of Westmeath enacts as follows:-

- 1. That the Corporation of the Township of Westmeath enters into an agreement with Bernard and Marie Zettler, known as Schedule I, attached to, and forming part of this By-Law.
- 2. That the Reeve and Clerk are hereby authorized to sign the agreement referred to in Section 1, on behalf of the Corporation.

THIS AGREEMENT made this but day of April, 1994
BETWEEN:

THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF WESTMEATH Hereinafter called the "Municipality"

OF THE FIRST PART

- and -

BERNARD ZETTLER and MARIE ZETTLER

Hereinafter called the "Owners"

OF THE SECOND PART

WHEREAS the Owners are the owners in fee simple of the lands described in Schedule "A" attached hereto in the Township of Westmeath, in the County of Renfrew.

AND WHEREAS the Owners have applied to the Land Division Committee of the County of Renfrew for consent to sever the said lands;

AND WHEREAS consent to sever has been granted on condition that if the severed lands and the lands being added to (Part 4 on 49R-10945) are conveyed in the future, they shall be conveyed as one parcel.

AND WHEREAS Section 53(2) of <u>The Planning Act</u>, R.S.O. 1990 chap. P.133 provides that Council has the same powers with respect to consent as the "Minister" (as defined in the said <u>Planning Act</u>);

AND WHEREAS Section 53(2) and Secion 51(6) of the said <u>Planning</u>

<u>Act</u> allows the municipality to enter into an agreement registered on title with respect to consents;

NOW THEREFOR THIS Agreement witnesseth that in consideration of the sum of ONE DOLLAR (\$1.00), now paid by each party to the other, and the mutual covenants hereinafter referred to, the parties hereto agree as follows:

- 1. The Municipality agrees to the severance of the lands described in Schedule "B" hereto from the lands described in Schedule "A"
- 2. The Owners agree that they shall not convey less than the whole of the lands described in Schedule "C" by way of Deed or Transfer, or grant, assign, or exercise a power of appointment with respect to the said lands, or mortgage or charge less than the whole of said lands, or enter into an Agreement of Sale and purchase of less than the whole of said lands or enter into any Agreement that has the effect

of granting the use of or right in less than the whole of said lands directly or be entitlement to renewal for the period for a period of twenty-one (21) years or more.

- The Parties agree that the Land Division Committee may issue 3. a Certificate of consent for the lands described in Schedule "B" whereafter the Owners may convey the said lands described in Schedule "C" to a third party.
- The Agreement shall be registered on the title of the lands described in Schedule "B" and "C".
- This Agreement shall be binding upon the owners, their 5. heirs, executors, administrators and assigns, including all subsequent owners of the lands described in Schedule "B" and Schedule "C".
