

THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

BY-LAW 94-22

A By-Law for the purpose of widening and straightening a municipal roadway being originally a forced road known as the River Road

WHEREAS the Corporation of the Township of Westmeath wishes to widen and straighten a municipal roadway originally being a forced road locally known as the "River Road";

AND WHEREAS all the lands to be acquired for said purpose have been duly surveyed and are attached hereto as Schedule "A";

AND WHEREAS pursuant to the municipal Act chapter M45 R.S.O. 1990 Section 297 a municipality has the authority to widen, straighten and acquire lands for road purposes;


AND WHEREAS no person has been deprived of egress or ingress and all persons with an interest being owners or persons with an interest being owners or persons with an interest in the land acquired, have indicated in writing their consent to this By-Law.

NOW THEREFORE THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF WESTMEATH ENACTS AS FOLLOWS:

1. That all of the lands outlined in Schedule "A" attached hereto be acquired by the Municipal Corporation of the Township of Westmeath and that the sum of ONE DOLLAR (\$ 1.00) be paid to the owner for each parcel acquired;
2. That the said lands be hereby dedicated as a highway to be used for road purposes;
3. That the Reeve and the Clerk are hereby authorized to execute whatever documents are necessary to complete the acquisition of the lands referred to in Schedule "A" attached and to take such steps as are required to complete the said acquisitions.

This By-Law shall come into effect of the day of passing.
