
BY-LAW NUMBER 94-26

A By-Law to amend By-Law Number 81-9 of the Corporation of the Township of Westmeath, as amended.

PURSUANT TO SECTION 34 OF THE PLANNING ACT, 1990, THE TOWNSHIP OF WESTMEATH HEREBY ENACTS AS FOLLOWS:

1. THAT By-Law Number 81-9, as amended, be and the same is hereby further amended as follows:
 - (a) Schedule "A" (Hamlet of Westmeath Detail Map) is hereby amended by rezoning lands from General Residential (R) to General Commercial (C), as shown on the Schedule "A" attached to this By-Law.
2. THAT save as aforesaid all other provisions of By-Law 81-9 as amended, shall be complied with.
3. This By-Law shall come into force and take effect on the day of final passing thereof.

PASSED and ENACTED this 21 day of December, 1994.

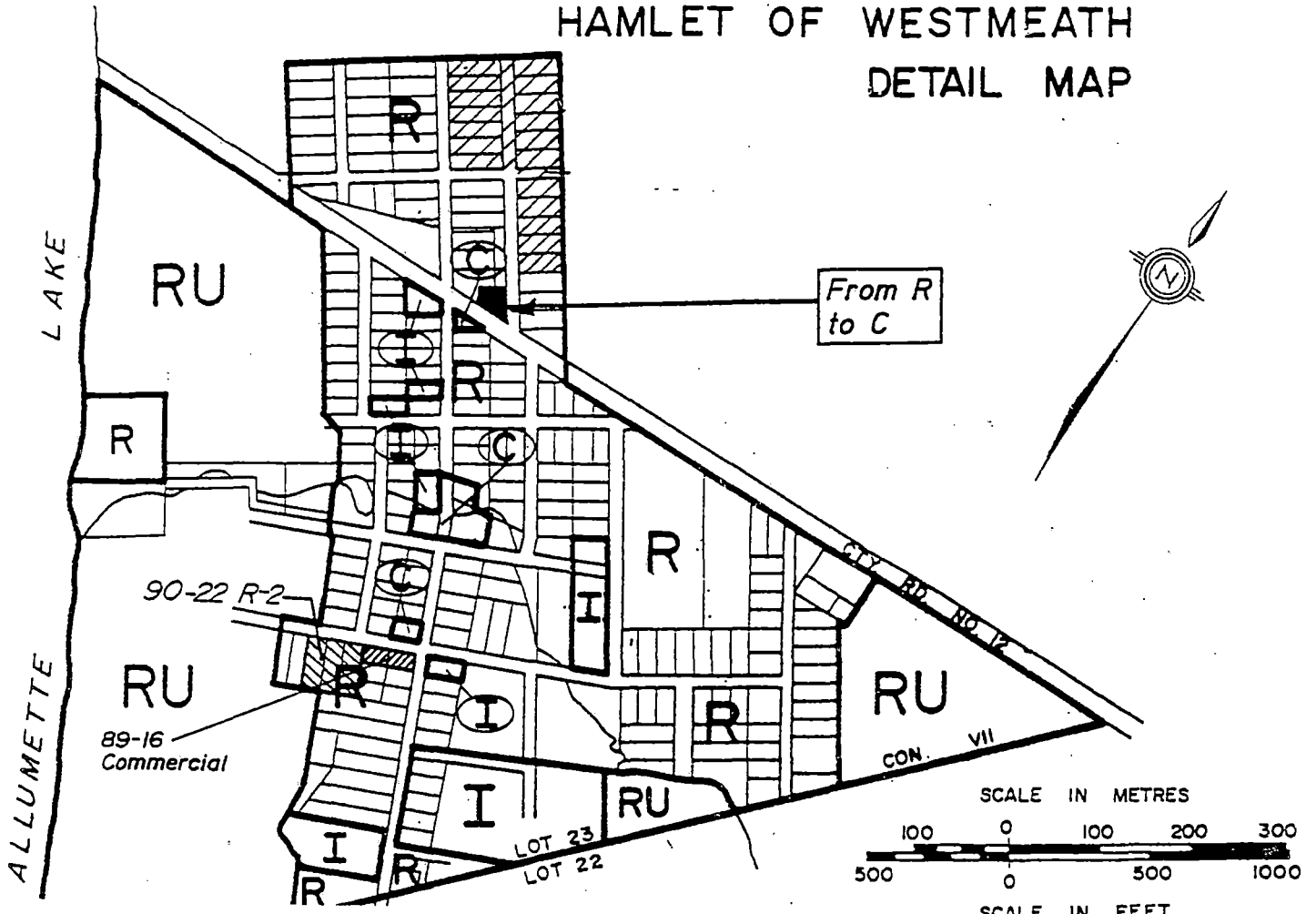

Public Involvement

Prior to the passing of this By-Law, a public meeting was held in order to permit interested persons an opportunity to make representations in support of or in opposition to the proposed amendment. The meeting was advertised in accordance with the provisions of the Planning Act and the Regulations.

Michael Thompson, the applicant, was present at the meeting. Letters were received from the Ministry of Natural Resources and the County of Renfrew Roads Department. They had no objections to the amendment. A letter had also been received from the Renfrew County and District Health Unit. They had no objection to the amendment providing that the business contemplated or operated on the property does not require any interior plumbing for a septic tank system.

There were no other comments or questions.
