A By-Law to amend By-Law Number 81-9 of the Corporation of the Township of Westmeath, as amended.

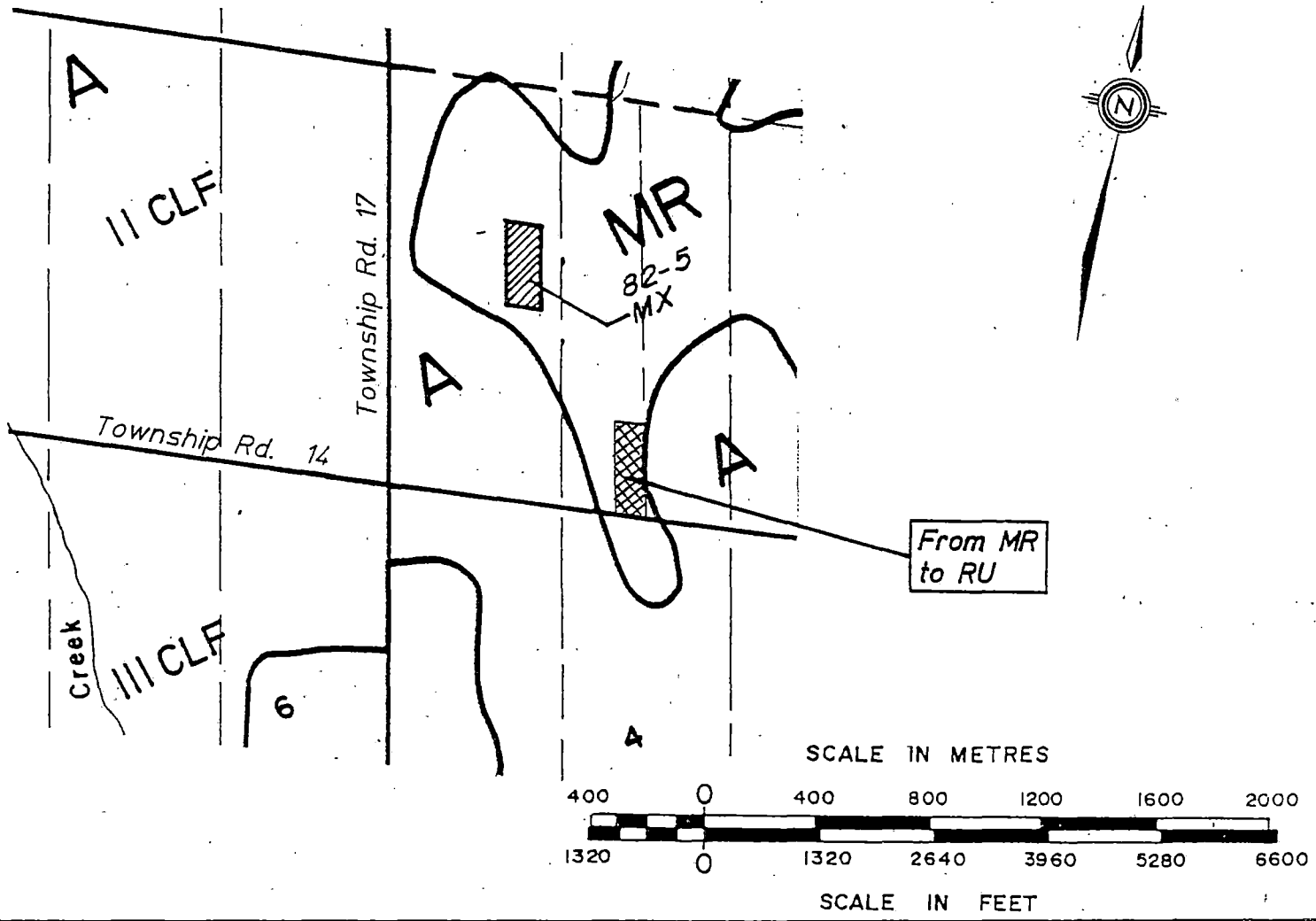
PURSUANT TO SECTION 34 OF THE PLANNING ACT, 1990, THE TOWNSHIP OF WESTMEATH HEREBY ENACTS AS FOLLOWS:

1. THAT By-Law Number 81-9, as amended, be and the same is hereby further amended as follows:
  - (a) Schedule "A" (Map 2) is hereby amended by rezoning lands from Mineral Resource (MR) to Rural (RU), as shown on the attached Schedule "A".
2. THAT save as aforesaid all other provisions of By-Law 81-9 as amended, shall be complied with.
3. This By-Law shall come into force and take effect on the day of final passing thereof.

- Area affected by this Amendment

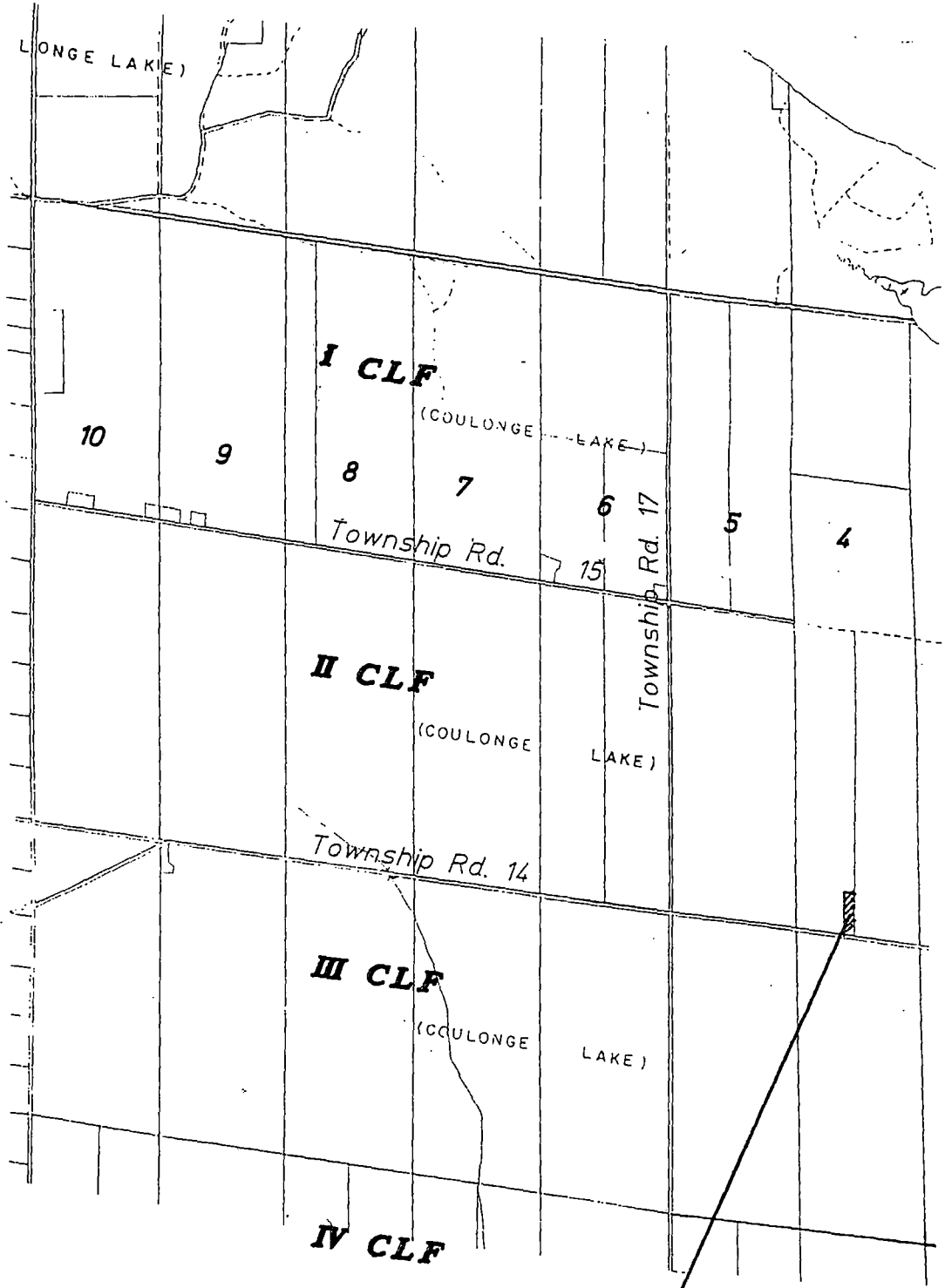
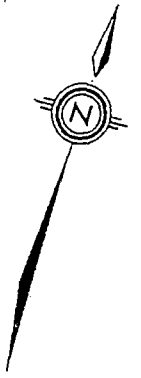
### Public Involvement

Prior to the passing of this By-Law, a public meeting was held in order to permit interested persons an opportunity to make representations in support of or in opposition to the proposed amendment. The meeting was advertised in accordance with the provisions of the Planning Act and the Regulations.

The purpose of this re-zoning is to permit a future severance of a residential lot with an existing dwelling on it. Arthur Bromley and Linda O'Brien-Bromley, the applicants, were present at the meeting to speak in favour of the proposed amendment. The proposed amendment had been circulated to the Ministry of Natural Resources, the Ministry of Agriculture and Food, the Renfrew County and District Health Unit and the County of Renfrew. Letters had been received from the Ministry of Natural Resources, County of Renfrew and the Renfrew County and District Health Unit stating that none of the above mentioned agencies had any objection to the proposed amendment.

There were no other comments or questions.

# WESTMEATH TOWNSHIP KEY MAP




**Location of Amendment**
