THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

BY-LAW NO. 95-21

A By-Law for the disposal of garbage in the Township of Westmeath.

WHEREAS:

The Municipal Act 1990 R.S.O. Chapter M45 Section 210, as amended by Bill 7 Statutes of Ontario 1993 Section 208.1 to Section 208.11 authorizes a municipality to pass by-laws to:

- A. Establish, maintain and operate a waste management system including services of facilities for the reduction, recycling and reuse of waste;
- B. To establish fees for the use of any part of a waste management system;
- C. Require persons generating waste to separate in class of waste at point of collection;
- D. Prohibit and regulate the dumping, treatment and disposal of waste and a waste management facility:

WHEREAS:

- 1. The Council for the Corporation of the Township of Westmeath wishes to extend the life of its garbage and refuse disposal site in the Township of Westmeath by limiting the amount of garbage and refuse disposed therein by the residents of the Township; and
- 2. It is necessary to enforce a system for the orderly separation and disposal of various types of garbage and refuse so as to facilitate disposal and limit infilling; and
- 3. It is necessary to impose surcharges for the disposal of garbage and refuse at the Westmeath Garbage Site to offset the cost of the supervision and operation thereof.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WESTMEATH ENACTS AS FOLLOWS:

- 1. All garbage and refuse delivered to the Westmeath Township Municipal Landfill Site for disposal therein or deposited at roadside for municipal collection, other than the following items, shall be contained in specially marked yellow (W) garbage bags available from the Township of Westmeath for a prescribed fee:
 - (i) raw wood and brush
 - (ii) metal items
 - (iii) tires
 - (iv) construction debris (excluding items otherwise set forth in this section)
 - (v) furniture
 - (vi) household appliances
 - (vii) yard and garden accessories
 - (viii) plumbing related fixtures (bathroom, kitchen)
 - (ix) masonry waste
 - (x) styrofoam and other forms of insulation and packaging
 - (xi) canvas and other large plastic coverings

- The above mentioned specifically defined items of waste (i) to (xi) shall not be collected at roadside but shall be permitted to enter the Westmeath Waste Disposal Site provided they are segregated by type, are clearly visible to the attendant, and payment of the tipping fee is made as per Schedule A and Schedule B hereto attached.
- Hospitality operators are entitled to receive a \$1 credit for every specially marked yellow (W) garbage bag which they deliver themselves to the Westmeath Township Municipal Landfill Site provided, upon entry to the landfill site, they present to the landfill site attendant an identification card which authorizes their business to receive a credit. The attendant will note the number of yellow garbage bags deposited by each qualifying hospitality operator and inform the Municipal Office accordingly. This credit amount will then be applied towards the \$3 per bag purchase price for specially marked yellow (W) garbage bags bought by the hospitality operator at the Westmeath Municipal Office location only.

Any hospitality operator found abusing this credit system must return his/her identification card thereby being denied of this privilege. The identification card is non-transferable.

4. No person shall deposit at roadside or deliver any waste to the Westmeath Disposal Site otherwise than as authorized by this By-Law and in addition no person shall deposit at the Westmeath Disposal Site in the absence of the attendant or without the specific authorization of the attendant. Any person who contravenes the provisions of this agreement shall be guilty of an offence and a minimum fine of \$1,000.00 for all subsequent offences.

This By-Law repeals By-Law 93-20.

FEE FOR THE DISPOSAL OF SPECIAL ITEMS

All other special items not listed in Schedule 'A' to this By-Law will be examined by the Council for the Corporation of the Township of Westmeath on an individual basis. It will be at Council's discretion to accept or reject the disposal of the special waste items at the Westmeath Municipal Landfill Site and to establish the tipping fee rates.
