

THE CORPORATION OF THE TOWNSHIP OF WESTMEATH

BY-LAW 99-20

A By-Law to enter into an agreement with Valley Contracting for compaction services at the landfill site.

WHEREAS:


1. A Municipality has authority under C.M. 45, Section 208.2 of the Municipal Act R.S.O. 1990 to pass by-laws to establish, maintain and operate a waste management system.
2. The Council of the Corporation of the Township of Westmeath intends to enter into an agreement with a company for compacting landfill waste and placing cover material.

NOW THEREFORE the Council of the Corporation of the Township of Westmeath ENACTS as follows:

1. The Reeve and Clerk are hereby authorized to sign a Letter of Understanding with Valley Contracting regarding landfill compaction services.
2. The Letter of Understanding mentioned in Clause 1 shall be known as Schedule "A" and forms part of this By-Law.
3. The term of the agreement shall be from June 28th, 1999 to December 31st, 2000.

SCHEDULE A

Landfill Compaction

Letter of Understanding
between
The Corporation of the Township of Westmeath
and
Valley Contracting

Landfill Compaction Services to consist of:

- Supply and Operation of an Excavator (minimum weight 43,000 pounds), for the purpose of compacting landfill waste and placing cover material.
- Supply and Operation of a Float or Trailer to transport the Excavator to and from the Landfill Site.
- Pushing, leveling and compacting household and construction waste designated for land filling in the active area of the site.
- Covering the compacted waste with a minimum depth of granular, earth or Timminco waste slag. All material will be supplied to the site by others and deposited as close as possible to the active waste area for access by the Compaction Contractor.
- Landfill Compaction and covering to be done on a weekly, every second, every third or every fourth week basis. Eight months of the year from April 1st to December 1st compaction is done on a weekly basis. The remaining 4 months can vary from weekly to every fourth week depending on weather conditions and volume of waste.
- Performing other work at the landfill site such as excavating areas for waste, shaping berms beyond that required to cover waste, etc. on an hourly rate basis. This work would be done in conjunction with the regular compaction service and would not require a special trip to the site.
- Compacting and covering operations must be done on Saturdays after 2:00 p.m. or Mondays before 10:00 a.m.

Landfill Compaction Services to commence on June 28, 1999 and remain in effect for 18 months (December 31, 2000) unless either party to the contract provides in writing one month notice of request to withdraw from the contract. Landfill Compaction Service will be performed as directed by Janota Patrick & Associates Ltd. who are presently engaged as Operations Managers of the landfill site.

Fees for Landfill Compaction Services:

- On Weekly Basis: \$350.00 + G.S.T. per visit
- On Monthly Basis: \$550.00 + G.S.T. per visit
- Hourly Rate for Extra Work: \$75.00 + G.S.T.
