## BY-LAW 2000-19

## A By-Law for the Establishment and Improvement of a Roadway

### WHEREAS:

- 1. The Municipal Act, Section 98 (1) provides that "the Council of every municipality may pass by-laws (a) for establishing and laying out highways."
- 2. The Municipal Council of the Corporation of the Township of Westmeath wishes to establish and approve as a municipal highway a roadway known as "The Highland Road" as set out and dedicated on Plan 487 registered in the Registry Office for Renfrew (49) on the 2<sup>nd</sup> day of August 1979.

NOW THEREFORE the Corporation of the Township of Westmeath enacts as follows:-

- 1. That the Roadway designated as Highland Road on Registered Plan 487 be established and accepted as a municipal highway by the Corporation of the Township of Westmeath.
- 2. That the Road be improved by the Township and receive maintenance in accordance with the Standards normally provided by the Township with respect to Township Roads.
- 3. That this acceptance of the aforesaid roadway for municipal purposes specifically does not include that portion of road designated as Portage Place.

PASSED and ENACTED this 19th Day of July, 2000.
