A By-law to amend By-law Number 23-92 of the former Corporation of the Township of Ross as amended.

---

PURSUANT TO SECTION 34 OF THE PLANNING ACT, THE TOWNSHIP OF WHITEWATER REGION HEREBY ENACTS AS FOLLOWS:

1. THAT By-law Number 23-92, as amended, be and the same is hereby further amended as follows:

(a) By adding the following new subsection to Section 21 - Requirements For Agriculture (A) Zone immediately following subsection 21.3 g):

“h) Agriculture - Exception Eight (A-E8) Zone

Notwithstanding any other provisions of this By-law to the contrary, for the lands located in the Agriculture - Exception Eight (A-E8) Zone, within Part of Lots 24 and 25, Concession 7, geographic Township of Ross, the following provision shall apply:


Lot Frontage (minimum) 265 metres”

(b) Schedule “A” to By-law 23-92 is amended by rezoning lands described as Part of Lot 24, Concession 7, geographic Township of Ross, from Agriculture - Exception Five (A-E5) to Agriculture (A), as shown as Item 1 on Schedule “A” attached hereto, and from Community Facility (CF) to Agriculture (A), as shown as Item 2 on Schedule “A” attached hereto. Schedule “A” is also amended by rezoning lands described as Part of Lots 24 and 25, Concession 7, geographic Township of Ross, from Agriculture (A) and General Industrial (GM) to Agriculture - Exception Eight (A-E8), as shown as Item 3 on Schedule “A” attached hereto.

2. THAT save as aforesaid all other provisions of By-Law 23-92, as amended, shall be complied with.

3. This by-law shall come into force and take effect on the day of final passing thereof.

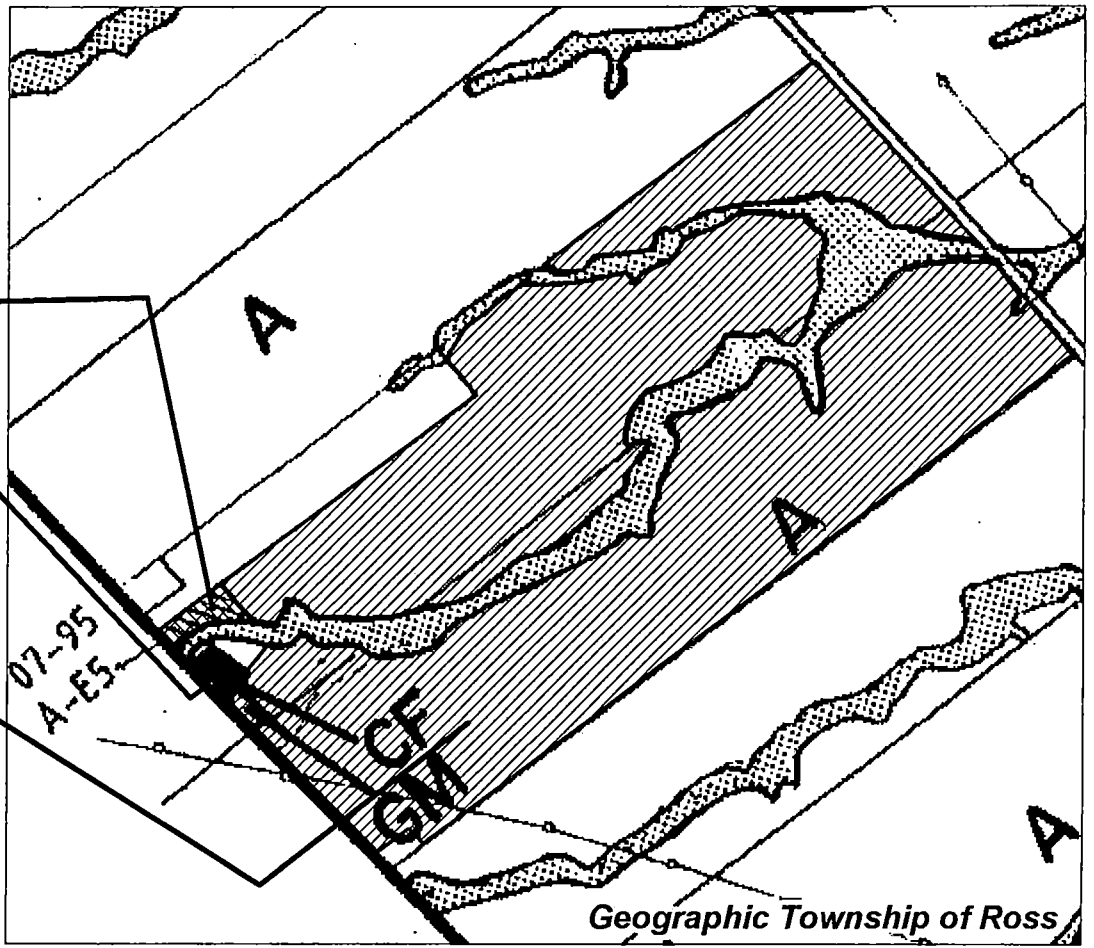

to A-E8





