A By-law to amend By-law Number 98-13 of the former Corporation of the Township of Westmeath as amended.

PURSUANT TO SECTION 34 OF THE PLANNING ACT, THE TOWNSHIP OF WHITEWATER REGION HEREBY ENACTS AS FOLLOWS:

- 1. THAT By-law Number 98-13, as amended, be and the same is hereby further amended as follows:
 - By adding the following text to <u>Section 14.0 Requirements for Rural (RU) Zone</u> in subsection 14.3(d) <u>Rural - Exception Four (RU-E4)</u> immediately following the words "shall be a permitted use.":

"The following provisions shall also apply to these lands:

Lot Area (minimum)2025 square metresLot Frontage (minimum)41 metres"

- (b) By adding the following new subsection to <u>Section 14-0 Requirements for Rural</u> (RU) Zone immediately after subsection 14.3(k):
 - "(1) <u>Rural Exception Twelve (RU-E12)</u>

Notwithstanding anything in this By-law to the contrary, for those lands located within part of Lot 12, Concession 3 East of Muskrat Lake, geographic Township of Westmeath, more particularly described as Part 3 on Reference Plan 49R-1121, and delineated as Rural - Exception Twelve (RE-E12) on Schedule "A" (Map 1) to this By-law, the following provisions shall apply:

(i) Lot A	rea (minimum)	2025 square metres

- (ii) Lot Frontage (minimum) 42 metres."
- (c) Schedule "A" (Map 1) to By-law 98-13 is amended by rezoning the lands described as Part 3 on Reference Plan 49R-1121 in part of Lot 12, Concession 3 East of Muskrat Lake, geographic Township of Westmeath, from Rural -Exception Four (RU-E4) to Rural - Exception Twelve (RU-E12) as shown on Schedule "A" attached hereto.
- 2. THAT save as aforesaid all other provisions of By-Law 98-13 as amended, shall be complied with.
- 3. This by-law shall come into force and take effect on the day of final passing thereof.
