2. That the said agreement attached and marked as Schedule 'A' shall form part of this by-law.
3. Former Township of Ross By-Law No. 40-98 enacted on the 18<sup>th</sup> day of November 1998 and the former Township of Westmeath By-Law No. 99-04 enacted 6<sup>th</sup> January 1999 are hereby repealed.




NOW THEREFORE, the Council of the Township of Admaston/Bromley enacts as follows:

**BETWEEN:**

**THE TOWNSHIP OF ADMASTON/BROMLEY, in the County of Renfrew,  
Hereinafter called "Admaston/Bromley" OF THE FIRST PART;**

**- AND -**

**THE TOWNSHIP OF WHITEWATER REGION, in the said County,  
Hereinafter called "Whitewater" OF THE SECOND PART;**

**WHEREAS, commencing January 1<sup>st</sup>, 2005 the Township of Admaston/Bromley and the  
Township of Whitewater Region have agreed to share the costs of the same Drainage  
Superintendent for training, membership and attending conferences, etc.,**


**THEREFORE, in consideration of the covenants and agreements hereinafter made and  
contained, the said two Townships agree as follows:**


1. The Township of Admaston/Bromley and the Township of Whitewater Region agree to share costs of the Drainage Superintendent as follows:  
  
Township of Admaston/Bromley – 50%  
  
Whitewater Region – 50%
2. The Drainage Superintendent shall keep track of all of his costs and which he will submit to the Clerk-Treasurer of the Township of Admaston/Bromley for payment.
3. After the Clerk-Treasurer has made payment she (he) will apportion the costs in accordance with 1 above and invoice the Township of Whitewater Region for its share.
4. The invoices will be submitted by the Clerk-Treasurer of the Township of Admaston/Bromley to the participating Municipality on a semi-annual or annual basis.

under the hands of the Reeve and Clerk duly authorized by By-Law.**




