BY-LAW # 06-06-242

Being a By-law to authorize Voting by Mail for the 2006 Municipal Election


WHEREAS Section 42 of the *Municipal Elections Act*, 1996 provides that a municipal council may pass a By-law authorizing an alternative voting method; and

WHEREAS Council deems it appropriate and in the public interest to conduct the 2006 municipal election using the "Vote By Mail" method.

NOW THEREFORE the Council of the Corporation of the Township of Whitewater Region enacts as follows:

1. **THAT** the alternative voting method of voting by mail is hereby authorized for the Municipal Election to be held in 2006.
2. **THAT** the clerk be authorized to establish appropriate procedures for voting by mail for the 2006 municipal election.
3. **THAT** no proxy voting or advance polls provisions are applicable at Municipal Elections conducted in accordance with this By-law.
4. **THAT** it shall be the responsibility of each elector to complete the ballots in accordance with the *Municipal Elections Act*, 1996, and the procedures authorized by this By-law and to return the completed ballots to the Clerk by mail, or by depositing the same at a Voting Day Ballot Return Station, on or before 8:00 p.m. on Voting Day.
5. **THAT** by shall come into force and take effect upon the date of the final passing thereof.

WHEREAS the lands to which this agreement applies are more particularly described in Schedule "1" annexed hereto and are located in Part Lot 15 Concession 1 East Muskrat Lake; Westmeath; Township of Whitewater Region, in the County of Renfrew.

AND WHEREAS the Owner has applied to the County of Renfrew for consent for conveyance of a residential **File Number B174/05(1)** pursuant to the provisions of the *Planning Act*, R.S.O. 1990, chapter P.13.


AND WHEREAS the County of Renfrew has required the parties hereto to enter into this Agreement.


NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the sum of ONE (\$1.00) DOLLAR of lawful money of Canada and other good and valuable consideration now paid by the Township to the Owner (receipt whereof is hereby acknowledged), and in consideration of the mutual covenants hereinafter expressed, the parties hereby covenant and agree with the other as follows:

1. Schedule are attached hereto and form part of this Agreement.
2. The parties agree that for the purposes of the Planning Act and any amendments hereto, Part 11 49R/16052 and Part 17 49R/16052 shall merge as one parcel.
3. Neither Part 11 49R/16052 nor Part 17 49R/16052 shall be conveyed separately. The said lands shall form one parcel. Any conveyance of part of that parcel shall require a consent pursuant to the provisions of the Planning Act, R.S.O. 1990, chapter 13, and amendments thereto.
4. The provisions of subsection 12 of the section 50 of the Planning Act do not apply to a future conveyance of either of the subject parcels.
5. This agreement shall be registered on title and shall be binding on the parties hereto, their heirs, executors, administrators, successors and assigns.

IN WITNESS WHEREOF the parties hereto have hereunto affixed their hands and seals and their corporate seal attested by the hands of their duly authorized officers.


