By Law # 06-08-247

A By-law to Authorize a user fee schedule for all Municipal Departments

WHEREAS Section 390 and 391 of the Municipal Act 2001 authorizes the Council and Local Boards to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of the municipality or the Local Board and for the use of its property;


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WHITEWATER REGION DOES HEREBY ENACT AS FOLLOWS:


1. That By-Laws # 04-04-154 & # 04-10-171 are hereby rescinded in its entirety;
2. That all Council resolutions or similar expressions, whether formal or informal, inconsistent with this By-law shall be deemed to be rescinded.
3. The fees and charges set out on the attached Schedules are hereby imposed and ratified. Set out as follows:

Schedule A - Administration Department
Schedule B - Building and Bylaw Enforcement Department
Schedule C - Public Works Department
Schedule D - Waste Management Department
Schedule E - Water and Sewer Department

4. All fees and charges set out in this by-law shall be payable prior to the provision of the service unless an agreement in writing is made to the contrary and approved by a municipal official.
5. In the event any fee or charge imposed herein remains unpaid after provision of the service or is otherwise in arrears, such fees or charges may be added to the Tax Roll for any real property in the municipality, the owner of which is responsible for paying the fee or charge and shall be collected in like manner as municipal taxes.
6. Council does hereby delegate to the Chief Administrative Officer of The Township of Whitewater Region, the authority to administer such fees and charges and approve such forms and procedures as may be required for the efficient administration of the fees and charges.
7. The fees set out in this By-Law shall be increased at the rate of inflation, based upon the Consumer Price Index for Ontario, when Council deems it appropriate.
8. This By-law shall come into force and effect upon being passed.

Surcharge: 20% surcharge applies to all of the above fees if permit application is received after work has begun.

The user fees charged by the Waste Management Department shall be as follows:

1) Municipal Domestic Garbage

Residential Curbside Garbage Pickup – Yellow Municipal Garbage Bag \$3.00
*All Domestic Garbage delivered to the Landfill Site will be assessed the same rate as the Curbside Yellow Municipal Garbage Bag

2) No person shall dump waste at the Whitewater Region Landfill Site without paying for each load, the following charges:

- a) All IC&I waste entering the site in large Containers or Dumpsters NOT COMPACTED shall be assessed at a rate of \$0.35 per cubic foot.
**FORMULA (Width x Height x Depth)
Or 1 cubic Yard = 27 cubic feet**
- b) IC&I waste in Compactor Truck \$0.60 per cubic foot
- c) General Residential Waste (not in bags) \$0.35 per cubic foot
- c) Refrigerated and Non-Refrigerated Appliances \$5.00 per item
- d) Discarded Furniture \$5.00 per item

3) A surcharge for payment at the landfill site will apply to the following:

- a) Request to open Landfill Site \$20.00 per Opening

4) CONTAMINATED SOIL: Hydrocarbon contaminated soil shall be considered a special waste and will be subject to a fee of \$0.60 per cubic foot

5) CONSTRUCTION & DEMOLITION WASTE: Subject to a fee of \$0.35 per cubic foot as defined in Section #2 above

6) BRUSH, LEAF & YARD WASTE: No Charge

7) SCRAP METAL: No Charge

6) TIRES: Tires will be subject to the following fees. No mounted tires on Rims will be accepted.
