A By-law to amend By-law Number 98-13, as amended, of the former Township of Westmeath.

---

**PURSUANT TO SECTIONS 34 AND 36 OF THE PLANNING ACT, R.S.O. 1990, c.P.13, THE TOWNSHIP OF WHITEWATER REGION HEREBY ENACTS AS FOLLOWS:**

1. THAT By-law Number 98-13, as amended, of the former Township of Westmeath is hereby further amended as follows:
  - (a) Schedule 'A' and 'B' to By-law Number 98-13, as amended, of the former Township of Westmeath is amended by rezoning lands located within Part of Lot 28, Concession West Front E, in the geographic Township of Westmeath, now in the Township of Whitewater Region, from Waterfront Vicinity-holding (WV-h) to Waterfront Vicinity(WV), as shown on Schedule "A" attached hereto.
2. THAT save as aforesaid all other provisions of By-law 98-13, as amended of the former Township of Westmeath, shall be complied with.
3. This By-law shall come into force and take effect on the day of final passing thereof.

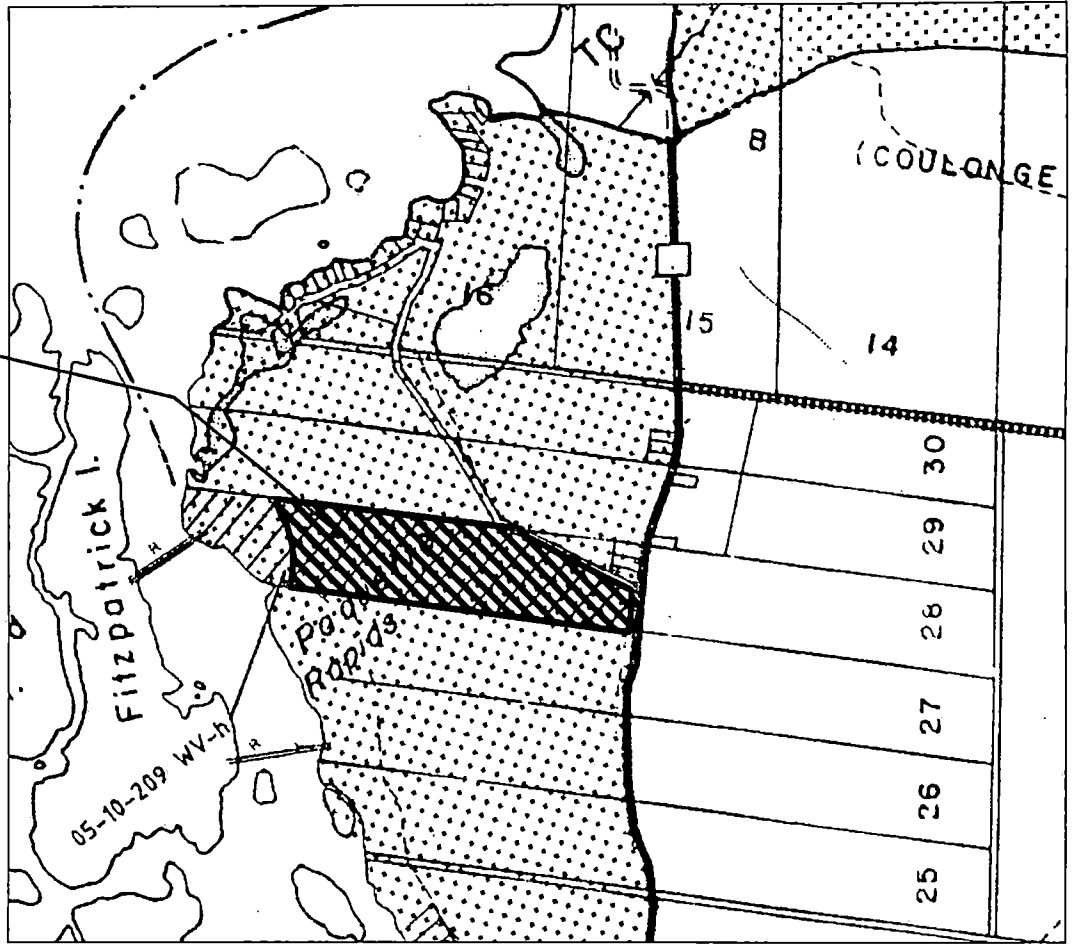

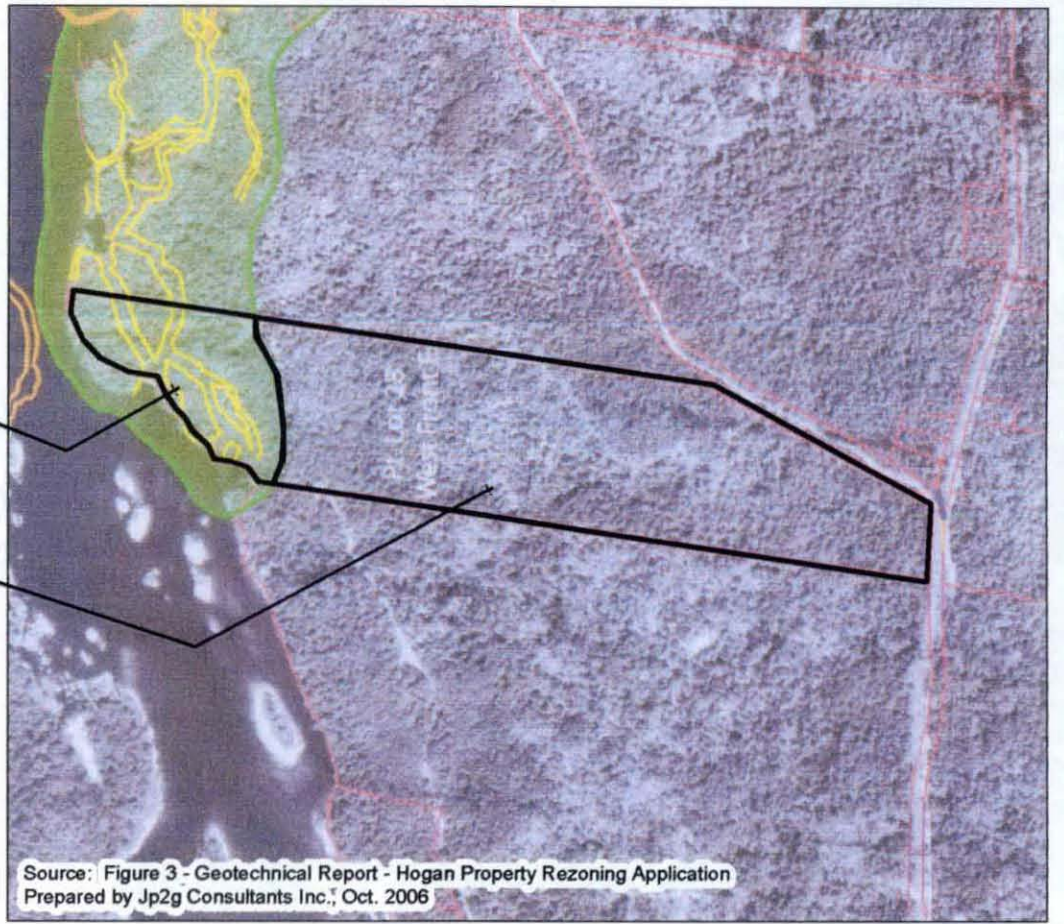
