**A By-Law to authorize the Township of Whitewater Region to enter into an Agreement regarding the control of animals.**



**WHEREAS** Pursuant to Section 11 (1) Sphere 9 of the Municipal Act R. S. O. 2001 authorizes a Municipality to enter into an agreement regarding the control of animals.

**NOW THEREFORE** the Council of the Corporation of the Township of Whitewater Region ENACTS as follows:

1. The Mayor and Clerk are hereby authorized to sign an agreement with Valley Animal Control Shelter regarding the sheltering of Animals
2. The Agreement mentioned in Clause 1. shall be known as Schedule "A" and forms part of this By-Law.
3. The term of the agreement shall be from April 27<sup>th</sup> to April 30, 2009.
4. By-law 06-12-272 is hereby repealed.
5. This By-law will come into force and take effect immediately upon passing.

**READ** a first time, a second time and finally passed this third reading this 4<sup>th</sup> day of April, 2007

**THE CORPORATION OF THE TOWNSHIP OF WHITEWATER REGION**

(Hereinafter referred to as the Corporation of the SECOND PART)

**WHEREAS** the Corporation is required to fulfill Municipal obligations set out by statute;

**AND WHEREAS** the Council of the Corporation desires to enter into an agreement for the provisions of animal shelter facilities, care and other related services;

**THEREFORE** the undersigned hereby agree as follows:

**Section I – Responsibility of Animal Shelter**

1. Shelter to be open and accessible to the residents of the Corporation between the hours of 9:00 a.m. – 6:00 p.m. Monday to Sunday.

**Section II – Compensation**


1. Basic Rent for Shelter Facilities \$ 300.00 per month.
2. Daily Boarding Fees \$ 10.00 per day.
3. Euthanasia & Cremation Fees \$ 1.40 per pound.
4. Veterinary Fees: Responsibility for payment shall rest with the Corporation, for sick or injured animals delivered to the Animal Shelter requiring care.

**Section III – Special Terms**

1. Both parties reserve the right for termination of the Agreement for the provisions of service within 60 days of written notice, given to the receiver of said service, without penalty, or compensation.
2. All the above prices are subject to Goods and Service Tax (GST).
3. This agreement shall be for a Term of Two (2) years commencing the 27<sup>th</sup> day of April, 2007 and ending on the 30<sup>th</sup> day of April, 2009.

**IN WITNESS WHEREOF** the Animal Shelter has executed this Agreement under the hand of its officer duly authorized in that behalf, and the Corporation has hereunto affixed its seal attested to by the signatures of its Mayor and CAO/Clerk.


