A By-law to Amend Waste Management Department 'Schedule D' of Tariff of Fees Bylaw 06 - 08 - 247

WHEREAS Section 390 and 391 of the Municipal Act 2001 authorizes the Council and Local Boards to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of the municipality or the Local Board and for the use of its property;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WHITEWATER REGION DOES HEREBY ENACT AS FOLLOWS:

- 1. That Schedule D of Bylaw 06 08 247 hereby be amended.
- 2. That all Council resolutions or similar expressions, whether formal or informal, inconsistent with this By-law shall be deemed to be rescinded.
- 3. The fees and charges set out on the attached Schedule D are hereby imposed and ratified.
- 4. All fees and charges set out in this by-law shall be payable prior to the provision of the service unless an agreement in writing is made to the contrary and approved by a municipal official.
- 5. Council does hereby delegate to the Chief Administrative Officer of The Township of Whitewater Region, the authority to administer such fees and charges and approve such forms and procedures as may be required for the efficient administration of the fees and charges.
- ⁶. The fees set out in this By-Law shall be increased at the rate of inflation, based upon the Consumer Price Index for Ontario, when Council deems it appropriate.
- 7. This By-law shall come into force and effect on January 1, 2008.
