BY-LAW NUMBER 08 - 02 - 326

A By-law to amend By-law Number 679 of the former Corporation of the Village of Beachburg, as amended.

PURSUANT TO SECTION 34 OF THE PLANNING ACT, THE TOWNSHIP OF WHITEWATER REGION HEREBY ENACTS AS FOLLOWS:

- THAT By-law Number 679, as amended, be and the same is hereby further amended as follows:
 - (a) By adding the following new subsections to <u>Section 5.0 Requirements for</u>

Residential Type 1 (R1) Zone, immediately after subsection 5.2(k):

"5.3 EXCEPTIONS

(a) Residential One-Exception One (R1-E1)

Notwithstanding Section 5.2(d), or any other provision of this By-law, for those lands located in part of Lot 6, Concession 5, geographic Township of Westmeath, in the former Village of Beachburg, and delineated as Residential One-Exception One (R1-E1) on Schedule "A" to this By-law, the minimum required side yard setback shall be 1.5 metres. All other provisions of the R1 Zone shall apply."

- (b) Schedule "A" is amended by rezoning those lands described as part of Lot 6, Concession 5, geographic Township of Westmeath, in the former Village of Beachburg, from Open Space (OS) to Private Open Space (POS) and from Residential One (R1) and Open Space (OS) to Residential One-Exception One (R1-E1), shown as Items 1, 2 and 3 on the attached Schedule "A".
- (c) Schedule "B" is a consolidation of the existing and proposed zoning and replaces Schedule "A" to By-law 679.
- 2. THAT save as aforesaid all other provisions of By-law 679 as amended, shall be complied with.
- 3. This by-law shall come into force and take effect on the day of final passing thereof.

This By-law given its FIRST and SECOND reading this <u>20th</u> day of <u>February</u> 2008.

This By-law read a THIRD time and finally passed this <u>20th day of February</u>, 2008.


