- 2. The said right-of-way shall be a private road only and the Township shall not assume any responsibility for the right-of-way.
- 3. The Mayor and Clerk shall be authorized to sign the deed of right-of-way on behalf of the Township.

WHEREAS the Municipal Corporation of the Township of Whitewater Region is the owner of the lands hereinafter described which lands are not a public road;

AND WHEREAS the said Township wishes to grant a right-of-way across the lands for the use of the Grantee at his own risk as a private laneway.

WITNESSETH that in consideration of the sum of ONE DOLLAR (\$1.00) paid by the Grantee to the Grantor grants to the Grantee, his heirs, executors, and assigns and occupants of the lands described in Schedule "A" attached hereto, a right-of-way for persons and vehicles over the following lands:
