

**THE CORPORATION OF THE TOWNSHIP OF WHITEWATER REGION**

**By-Law No. 09-05-383**

---

A By-Law for the purpose of the realignment of a section of a municipal road known as Zion Line

---

**WHEREAS** the Municipal Act, Bill 111, Chapter 25 S. O. 2001 grants in Section 11(1) jurisdiction to single tier Municipalities with respect to Highways.

**AND WHEREAS** Section 66(1) and Section 67 (1) of the said Municipal Act provides for the transfer of surplus lands to adjacent owners whose land had previously been utilized for the diversion of the Highway.


**AND WHEREAS** Gerald George Robinson and Lisa Anita Robinson are the owners of certain lands and have agreed to the sale of these lands to the Municipality for the purpose of realigning Zion Line.


**AND WHEREAS** Kevin Malcolm Coughlin and Marilyn Jean Coughlin are owners of certain lands presently used as Zion Line and have agreed to transfer the said lands to the Municipality for road purposes.

**NOW THEREFORE** the Council of the Corporation of the Township of Whitewater Region ENACTS that:

- (a) The lands more particularly described as Part of Lots 3 & 4, Concession 2 East of Muskrat Lake, Ross, being Parts 2, 3, 4, 5, 6, 7, 8, 9, 11 and 12 on Reference Plan 49R-16971, now in the Township of Whitewater Region, County of Renfrew, hereby be acquired from Gerald George Robinson and Lisa Anita Robinson for road purposes.
- (b) The lands more particularly described as Part of Lot 3, Concession 2 East of Muskrat Lake, Ross, being Part 13 on Reference Plan 49R-16971, now in the Township of Whitewater Region, County of Renfrew, hereby be acquired from Kevin Malcolm Coughlin and Marilyn Jean Coughlin for road purposes.
- (c) The lands more particularly described as Part of Lots 3 & 4, Concession 2 East of Muskrat Lake, Ross, being Parts 4, 5 and 11 on Reference Plan 49R-16971, now in the Township of Whitewater Region, County of Renfrew, hereby be transferred to Gerald George Robinson and Lisa Anita Robinson.
- (d) The lands more particularly described as Part of Lots 3 & 4, Concession 2 East of Muskrat Lake, Ross, being Parts 2, 3, 6, 7, 8, 9, 12 and 13 on Reference Plan 49R-16971, now in the Township of Whitewater Region, County of Renfrew, are hereby assumed and dedicated as part of the Municipal Highway system and are now part of Zion Line.
- (e) The Mayor and the Clerk are hereby authorized to execute whatever documents are required to facilitate the above-mentioned purchase and acquisition.
