1. The Township of Whitewater Region hereby authorizes the Mayor and Clerk to execute the engineering costs agreement with the Ministry on Transportation (Schedule "A").

Letter of Understanding Required Works of Detailed Design For the rehabilitation of Highway 17 in the Village of Cobden

This is to serve as a Letter of Understanding ("Understanding") between The Corporation Of The Township Of Whitewater Region (Municipality) and Her Majesty the Queen in right of the Province of Ontario, as represented by the Minister of Transportation for the Province of Ontario ("MTO"), regarding the Engineering Detailed Design costs associated with the pavement rehabilitation of Highway 17 from station 11+800 to 13+700 in the Village of Cobden. In consideration of the terms of this Understanding and the sum of Ten Dollars (\$10.00) of lawful money of Canada paid by each of the parties to the other, the receipt of whereof is hereby acknowledged, and other good and valuable consideration, the parties understand and agree as follows.

The Corporation Of The Township Of Whitewater Region agrees and recognizes that as the MTO having permit control and jurisdiction over land development adjacent to and surrounding Highway 17 and that MTO will contribute a one time payment of \$31,501.00 + GST dollars (Canadian) for Detailed Design costs associated with the pavement rehabilitation of Highway 17 from station 11+800 to 13+700.

DETAILED DESIGN

- 1. The "Municipality", as the proponent, shall:
 - comply with the Environmental Assessment Act and the Ministry of Transportation Class Environmental Assessment for Provincial Transportation Facilities process and;
 - obtain from the Ministry of Environment, as well as the Ministry of Natural Resources, all clearances required by the Act.
- 2. The "Municipality" shall retain the services of a consulting engineer to prepare the detailed design for the reconstruction of the pavement in the Village of Cobden as per the agreed to terms described in section 1.0 Modification to Tender Package for MTO Works in the letter to the Township, dated May 7, 2012 and modified by email dated May 30, 2012. (attached).
- 3. The "Municipality" shall design and prepare, according to the Ministry's standards and specifications, the contract drawings and documents for the construction of the rehabilitation of the pavement, which shall be approved in writing by the Regional Director prior to the tendering and the construction of the Work
- 4. The "Municipality" and the Minister of Transportation shall enter into a cost share agreement prior to the construction of the pavement rehabilitation.

Letter of Understanding Required Works of Detailed Design For the rehabilitation of Highway 17 in the Village of Cobden

This is to serve as a Letter of Understanding ("Understanding") between The Corporation Of The Township Of Whitewater Region (Municipality) and Her Majesty the Queen in right of the Province of Ontario, as represented by the Minister of Transportation for the Province of Ontario ("MTO"), regarding the Engineering Detailed Design costs associated with the pavement rehabilitation of Highway 17 from station 11+800 to 13+700 in the Village of Cobden. In consideration of the terms of this Understanding and the sum of Ten Dollars (\$10.00) of lawful money of Canada paid by each of the parties to the other, the receipt of whereof is hereby acknowledged, and other good and valuable consideration, the parties understand and agree as follows.

The Corporation Of The Township Of Whitewater Region agrees and recognizes that as the MTO having permit control and jurisdiction over land development adjacent to and surrounding Highway 17 and that MTO will contribute a one time payment of \$31,501.00 + GST dollars (Canadian) for Detailed Design costs associated with the payement rehabilitation of Highway 17 from station 11+800 to 13+700.

DETAILED DESIGN

- 1. The "Municipality", as the proponent, shall:
 - comply with the Environmental Assessment Act and the Ministry of Transportation Class Environmental Assessment for Provincial Transportation Facilities process and;
 - obtain from the Ministry of Environment, as well as the Ministry of Natural Resources, all clearances required by the Act.
- 2. The "Municipality" shall retain the services of a consulting engineer to prepare the detailed design for the reconstruction of the pavement in the Village of Cobden as per the agreed to terms described in section 1.0 Modification to Tender Package for MTO Works in the letter to the Township, dated May 7, 2012 and modified by email dated May 30, 2012. (attached).
- The "Municipality" shall design and prepare, according to the Ministry's standards and specifications, the contract drawings and documents for the construction of the rehabilitation of the pavement, which shall be approved in writing by the Regional Director prior to the tendering and the construction of the Work.
- 4. The "Municipality" and the Minister of Transportation shall enter into a cost share agreement prior to the construction of the pavement rehabilitation.

Dear Sir:

Further to the meeting held on April 25th, 2012 with Chris Belanger of MTO, we are providing for your review the following summary of engineering fees as related to the extension of the Township's watermain reconstruction contract to also include the resurfacing of Highway 17 through the Village of Cobden. Based on the meeting, we understand that, in general terms, the scope of work to be covered under the road resurfacing work is as follows:

- Mill and repave the roadway from the previous contract limits at both the east and west ends of Cobden. MTO's geotechnical section will confirm the depth of removal, but it is anticipated that it would be in the order of 100mm depth milling, and repaving in 2 lifts. The mill and paving work will extend to MTO's right-of-way limits for all intersecting roadways.
- · Line painting upon completion of the repaving operation.
- Minor curb repairs wherever the curb is either currently removed and/or severely damaged.
 These locations are to be documented and approved by MTO prior to tendering the work.
- Residential driveways are to be repaved approximately 2m beyond the edge of pavement and commercial driveways are to be repaved to the limit of MTO's right-of-way.
- Reinstate the paved and granular shoulders in the sections where there are no curbs.
- The paved boulevard behind the curb is only to be repaired where it is severely damaged. These
 locations are to be documented and approved by MTO prior to tendering.

1.0 Modification to Tender Package for MTO works

To date, our office has completed the detailed design work for the watermain replacement, including preparation of specifications and tender documents. In order to add the road resurfacing works to this tender, and have the Township tender all of the work (with MTO reimbursing the Township for its share of the work) we would have to undertake the following work:

- 1. Obtain the digital drawings and mapping that MTO has for the area.
- 2. Undertake a site review to document with pictures and road chainage the following:
 - · any area of severe curb damage,
 - · areas where the curb has been removed.
 - areas of the roadway that should be repaired with full depth excavation, rather than just milling and repaying,
 - areas of the paved boulevard that are severely damaged and in need of repair,
 - · any road drainage issues that need to be addressed.
- 3. Prepare a report, to be submitted to MTO, documenting the damaged areas noted in item 2 and seek MTO's approval to include these works in the tender package.
- Prepare base plans at a scale of 1:1000 for the length of the resurfacing project, based on the digital information provided by MTO.

- 5. Prepare the detailed plan & profile, details and pavement marking drawings. These will note the limit of the works, all areas of spot improvements, repairs to the storm sewer, etc.
- 6. Prepare specifications for the resurfacing works based on OPSS.
- 7. Modify the form of tender to incorporate the additional work items for the resurfacing.
- 8. Incorporate any changes required in the contract documents for the additional scope of work.
- 9. Prepare a cost share summary for the Township and MTO's review.
- Submit the final package to MTO for review, including the drawings, tender document and cost share summary.
- Attend meeting for the identification of scope of work items and final hand over by MTO for construction.

Based on the attached Work Breakdown Sheet, we have estimated that our engineering fees for this work would be \$31,400. Since the Township has already paid for the preparation of the watermain design drawings and tender documents associated with that aspect of the project, this additional cost should be paid by MTO, as it relates solely to the cost of the design for the repaving contract and the work to modify the tender documents to include this work. We would be prepared to complete the work for a lump sum of \$33,501.00 and we anticipate that we would have the revised tender package available for MTO's approval in 6 weeks.

2.0 Contract Administration and Field Review

The work involved in section 1.0 would result in the development of a tender package incorporating all of the work involved in the Township's watermain reconstruction project and the MTO's resurfacing contract. We understand that this document would then be advertised for a competitive bid by the Township and that the Township would be responsible for administration of the contract and for the field review. MTO would then compensate the Township for its share of both the engineering and construction costs, based upon a predetermined cost sharing formula.

Under this aspect of the project, we would provide the following services:

- Prepare and publish the tender ad for the project which will be published in the local newspapers as well as the Township's website,
- 2. Respond to inquiries from bidders during the tender period,
- 3. Prepare addenda as required,
- 4. Attendance at the tender opening, including preparation of the tender report for the Township's and MTO's consideration.
- 5. Preparation of the contract documents for signing and forwarding of award letter to the successful tenderer,
- 6. Arrange for and attend at the pre-construction meeting,
- Perform Construction Liaison duties as required,
- 8. Undertake full-time field review by a senior field representative and one assistant for the duration of the construction project, which we anticipate will be 8 weeks,

- Undertake contract administration services, including preparation of monthly payment certificates, recommendations on any contractor or owner generated contemplated change orders, attendance at weekly site meetings, and provision of weekly status reports to the Township and MTO,
- Arrange for Quality Assurance of the Contractor's Quality Control for the concrete, asphalt and associated works,
- Undertake reviews at the completion of the project as well as at the end of the maintenance period.

Based on the anticipated 8 week construction timeframe for this project, our lump sum fee to undertake items 1 to 10 would be \$85,000, which would be cost shared between the Township and MTO.
