THE CORPORATION OF TOWNSHIP OF WHITEWATER REGION

BY-LAW NUMBER 12-09-556

A By-law to amend By-law Number 98-13 of the former Corporation of the Township of Westmeath as amended.

PURSUANT TO SECTIONS 34 AND 36 OF THE PLANNING ACT, THE TOWNSHIP OF WHITEWATER REGION HEREBY ENACTS AS FOLLOWS:

- 1. THAT By-law Number 98-13, as amended, be and the same is hereby further amended as follows:
 - (a) By adding the following new subsection to <u>Section 14.4 INTERIM USES</u>

 <u>AND STANDARDS (HOLDING)</u> immediately after subsection 14.4(a) <u>Rural-holding (RU-h)</u> (Part Lots 14 & 15, Concession 6 EML Lookout Road):
 - (b) <u>Rural-holding (RU-h) (Part Lot 6, Concession 3 Coulonge Lake Malloy Road)</u>

Until such time that the holding symbol is removed from the land zoned RU-h and described as Part of Lot 6, Concession 3 Coulonge Lake, in the geographic Township of Westmeath, now in the Township of Whitewater Region, no person shall use land or erect or use any building or structure except in accordance with the following:

- (1) Permitted Uses
 - existing uses in existing locations
 - open space
 - passive recreation that does not require a building
- (2) Conditions for removal of Holding Symbol (h)


The condition that must be satisfied prior to the removal of the holding symbol is:

- (i) The digging of test holes to identify a suitable building site as set out in the County of Renfrew karst protocol."
- (b) Schedule "A" (Map 2) to By-law 98-13 is amended by rezoning the lands described as part of Lot 6, Concession 3 Coulonge Lake from Rural (RU) to Rural-holding (RU-h), as shown on Schedule "A" attached hereto.
- THAT save as aforesaid all other provisions of By-law 98-13 as amended, shall be complied with.
