Being a By-Law to authorizing Council to enter into a an agreement with the Ministry of Natural Resources regarding 2012 CFWIP Project Cobden Marsh Enhancement as well as Volunteer Agreement.


WHEREAS pursuant to the *Municipal Act, 2001* (Ontario), a Council may enter into Agreements;

AND FURTHER that the Municipal Council for the Township of Whitewater Region deems it beneficial to enter into contract with Ministry of Natural Resources;

Notice of Approval/Project Agreement

Community Fisheries/Wildlife Involvement Project

Your Community Fisheries/Wildlife Involvement project proposal has been reviewed and approved for the fiscal year 2012/2013.

The following are the terms and conditions of the approval:

The proponent **Whitewater Region** has approval to carry out a CFWIP project referred to as "«Habitat Enhancement and Interpretive Trail " " and according to the plans submitted with the project application. The following special conditions apply:

The Proponent will provide the following:

5. A completed volunteer agreement form before the start of the project. Should volunteers change during the life of the project, an amended volunteer form showing the new names must be provided to ensure the appropriate insurance remain in effect for those volunteers.
6. A signed copy of this agreement.
7. Appropriate invoices (with MNR summary form) indicating costs and expenditures
8. A summary of the accomplishments of the project (report form) to be submitted to the Ministry by January 1, 2013.

The Ministry of Natural Resources will provide funding up to \$ «2000.» and technical advice for the project.

All equipment and materials purchased with the approved funds will remain the property of the Ministry of Natural Resources. The proponent will be responsible for the removal of all equipment and materials from the project site and will ensure the site is left in a neat and tidy state after the project is completed.

Any changes to the plan occurring during project implementation must be discussed with the MNR representative prior to the work being carried out.

This is a notification letter only. It is the responsibility of the proponent to obtain any required permits or documentation prior to starting any work.
