

Section 1.0 Introduction

1.1 Definitions

In this Agreement:

- "Agricorp" means a crown corporation under the Agricorp Act, 1996
- Site Owner" means the party who owns the property where the rain gauge is located
- "Forage Rainfall Plan" (FRP) means the weather derivative plan that insures forage growers against insufficient and excess rainfall
- "Agent" means the entity contracted to provide rainfall collection services

1.2 Purpose of Agreement

This agreement permits Agricorp and its designated agent to install equipment, collect data, maintain equipment, and/or remove equipment on the site owner's property for the FRP. This agreement permits Agricorp and its designated agent access to the property and rain gauge for a period of three years commencing March 1, 2016 and ending November 1, 2018.
