#### CORPORATION OF THE TOWNSHIP OF WHITEWATER REGION

### BY-LAW # 16-07-882

BEING a By-Law to amend By-Law#16-06-868 and Schedule "B" of By-Law 16-06-868, adoption of water and sewer services rates.

BEING a By-Law to adopt estimates of all sums required for Municipal utilities purposes and to set water and sewage service rates.

WHEREAS, The Municipal Act, 2001 S.O. 2001, c25, Section 391 provides that a municipality may pass bylaws imposing fees or charges for public utilities services provided by it;

NOW THEREFORE, the Council of the Township of Whitewater Region enacts as follows:

- There is imposed, as set out in Appendix "B", water and wastewater rates for all water treated, distributed and all wastewater received, treated and disposed of by the Corporation of the Township of Whitewater Region. The volume of wastewater will be based upon 100% of the Flat Rate Water. Properties that are serviced by the municipal water system but are not connected to the municipal wastewater system will not be subject to wastewater rates.
- Payments are due on the "Due Date" shown on the invoice.
- 3. Fees and charges that are due and unpaid will be charged a penalty of one (1) percent per month. Costs incurred by the municipality in collecting unpaid fees and charges shall be added to the amount due and owing. The Treasurer may add unpaid fees and charges to the tax roll of the property to which the service was provided and collect them in the same manner as municipal taxes.
- Appendix "A" identifying rate categories is hereby adopted as part of this by-law.
- That water and sewer billing are payable at the Township of Whitewater Region, Box 40, 44 Main Street, Cobden, Ontario or at the Bank of Nova Scotia, Pembroke, Beachburg, Cobden, through telebanking with all major banks or Pre-Authorized Payment arranged through the Township of Whitewater Region.
- 6. This By-Law and Appendix "A" and "B" of this By-Law shall come into force and take effect January 1, 2016.
- 7. All By-Laws or parts of By-Laws previously passed that are inconsistent with the provisions of By-Law 16-07-882 are hereby repealed.
