## By-law Number 17-01-911

---

### **Being a by-law to appoint Council Members to Committees, Boards & Commissions for 2017-2018**

**Whereas**, Section 5 of the Municipal Act, 2001 S.O. 2001, c.25 as amended states that the powers of a municipality shall be exercised by its Council and generally through by-law; and

**Whereas**, the Procedural By-law in force and effect confers responsibility to the Mayor for appointments to Standing Committees and Ad Hoc Committees with Council to determine appointments to Boards & Commissions; and

**Whereas**, Council deems it expedient and necessary to confirm Council appointees for the remainder of the term;

### **Now therefore Council of the Corporation of the Township of Whitewater Region enacts as follows:**

1. That By-law 15-04-794 is hereby amended to repeal and replace subsection 2(30) to read as follows:

4. That the following Council Members and representatives are appointed to **Boards & Commissions** for the remainder of the Council term:


