By-law Number 17-12-1023

Being a by-law to impose special annual drainage rates upon land in respect of which money is borrowed under The Tile Drainage Act (ValleyBio Ltd.)

Whereas, owners of land in the municipality have applied to the Council under The Tile Drainage Act, for loans for the purpose of constructing sub-surface drainage works on such land; and

Whereas, the Council has, upon their application, lent the owners the total sum of \$21,200 to be repaid with interest by means of rates hereinafter imposed;

Be it therefore enacted by the Council of the Township of Whitewater Region that annual rates as set out in the Schedule attached hereto are hereby imposed upon such land as described for a period of ten years, such rates to be levied and collected in the same manner as taxes.

Read a first, second and third time and finally passed this 20th day of December, 2017.
