CORPORATION OF THE VILLAGE OF COBDEN

BY-LAW NO. 841

A BY-LAW TO PROVIDE REMUNERATION TO THE HEAD AND MEMBERS OF COUNCIL.

WHEREAS Sections 231 and ⁴⁴⁴~~445~~ of the Municipal Act Provide that a Council may pay an annual allowance to the Head and Members of Council.

Municipal Council of the

THEREFORE the Corporation of the Village of Cobden enacts as follows:

1. THAT the Head of Council shall be paid \$ ~~5.00~~ for each meeting regularly called and held which he attends, provided however that not more than \$ ~~36.00~~ ^{60.00} aggregate shall be paid for such attendances in any calendar year.

2. THAT each member of council shall be paid \$ 3.00 for each meeting regularly called and held which he attends.
