

A BY-LAW TO PROVIDE FOR THE 1952 EXPENDITURE ON ROADS OR STREETS
IN THE TOWN VILLAGE OF Calden IN THE COUNTY DISTRICT OF PENFREW

WHEREAS under The Highway Improvement Act a by-law to provide for expenditure on roads or streets may be submitted annually to the Minister of Highways for approval.

THEREFORE the council of the corporation of the said town village enacts as follows:

- (1) The sum of \$ 4500.00 is hereby appropriated from monies raised by levy, debentures and government subsidy for total expenditure on construction and maintenance of the roads or streets under its jurisdiction during the year 1952 as follows:
