

BY-LAW NO. 916

A by-law for fixing a time and place for holding a nomination meeting and for polling and for providing for certain municipal officers.

Whereas it is expedient to provide by by-law for the fixing of a time and place for holding an election meeting for the receiving of nomination for Reeve and Councilors and School Trustees and for polling for same and for appointing certain municipal officers.

Therefore the Municipal Council of the Village of Cobden enacts as follows;-

That the meeting for the receiving of nominations for Reeve and Councilors and School Trustees shall be held in the Memorial hall on the 24 day of November 1952 from the hours Seven-Thirty P.M. to the hour of Eight-Thirty P.M.

That in case a poll be demanded such poll shall be held in memorial hall on the 1 day of Dec 1952 from the hour of Eleven O'clock A.M. to the hour of Seven O'clock P.M.

That the following Persons are hereby appointed to act as Municipal Officers-

D.R.O. J.A. Sammon.....

Poll Clerk. D.M. Morris.....

That the Clerk is hereby instructed to give and publish the necessary notices and to hold the meeting as aforesaid at the time and places mentioned and in such manner as directed by the statutes of Ontario.

BY-LAW NO. 915

A by-law authorizing an application to The Ontario Municipal Improvement Corporation for the purchase by it of certain debentures.

WHEREAS by Order dated the 27th day of August P.F.C. 2172 (File No. P.F.C. 6373) The Ontario Municipal Board authorized the construction of The completion of sewerage system, and the extension of water-works system, including a pumping station at an expenditure of \$ 77,900.00 and the enactment of the necessary debenture by-law;

THEREFORE the Council of The Corporation of the Village of Cobden enacts:

- 1. That the head of council and the clerk are authorized to make application to The Ontario Municipal Improvement Corporation for the purchase by it of the debentures of The Corporation of the Village of Cobden in the amount of \$ 77,900.00
