

BY-LAW NO 977

A BY-LAW FOR THE APPOINTMENT OF A VILLAGE FOREMAN, SUPERINTENDENT OF COBURN WATER & SEWERAGE SYSTEM, ENFORCER OF VILLAGE BY-LAWS, LICENCES COLLECTOR, WEED INSPECTOR, AND ALL OTHER DUTIES TO THE OPERATION OF THE VILLAGE STREETS, BUILDINGS AND ETC.

THEREFORE IT IS EXPEDIENT TO PROVIDE BY BY-LAW FOR THE APPOINTMENT OF VILLAGE FOREMAN, SUPERINTENDENT OF THE VILLAGE WATER & SEWERAGE SYSTEM, ENFORCERS OF VILLAGE BY-LAWS, COLLECTOR WEED INSPECTOR, AND ALL OTHER DUTIES FOR THE OPERATION OF THE VILLAGE STREETS, BUILDINGS AND ETC.

THEREFORE MR. J.B. McINTYRE IS HEREBY APPOINTED TO FULFILL THE FOREMAN POSITION UNDER THE FOLLOWING CONDITIONS AND DUTIES SPECIFIED HEREIN AFTER MENTIONED

TO BE EMPLOYED UNTIL FIFTEEN DAYS NOTICE BE GIVEN BY EMPLOYER OR EMPLOYEE.

AS VILLAGE FOREMAN HE WILL OVER SEE THE WORK OF THE MAINTENANCE MAN AND THOSE OF ANY OTHER PERSONS EMPLOYED BY THE VILLAGE.

AN MONTHLY REPORT BE SUBMITTED TO THE CLERK OF ALL PHASES OF VILLAGE WORK.

HE WILL BE SUBJECT TO AND WILL RECEIVE HIS ORDERS AT ALL TIMES FROM THE COMMITTEES OF COUNCIL HAVING JURISDICTION OVER THE VARIOUS PHASES OF HIS DUTIES.

TWO WEEKS VACATION WITH PAY FOR EACH FULL YEAR OF EMPLOYMENT.
