BY/LAW No. 997

A BY-LAW OF THE CORPORATION OF THE WILLAGE OF COBDEN TO REGULATE THE KEEPING AND CONTROL OF ANIMALS; THE LICENCING AND RESTRAINT OF DOGS; THE TAKING UP AND IMPOUNDMENT; THE QUARANTINING AND DESTRUCTION OF DOGS IN CERTAIN INSTANCES AND CERTAIN OTHER ASPECTS OF ANIMAL CONTROL WITHIN THE VILLAGE OF COBDEN.

The Council of the Corporation of the Village of Cobden enacts as follows:

1. <u>Definitions</u> - As used in this By-law, the following terms shall have the meaning hereinafter ascribed to them:

Corporation - Corporation shall mean the Corporation of the Village of Cobden.

Owner: - Any person, group of persons, partnership or corporation owning, keeping or harboring animals.

<u>Kennel:</u> - Any person, group of persons, partnership or corporation engaged in the commercial business of breeding, buying, seelling or boarding dogs and cats. -> Amended 1301

Pet Shop: - Any person, group of persons, partnership or corporation operating an establishment where live animals and birds are kept and offered for sale.

<u>Veterinary Hospital</u>: - Any establishment maintained and operated by a licensed veterinarian for the diagnosis and treatment of diseases and injuries ofanimals and birds.

Dog: - The male of the domesticated canine species.

Bitch: - The female of the domesticated canine species.

Spayed female: - A bitch or female animal which has been operated upon by a licensed veterinatian to prevent conception.

Animal Shelter: - Any premises designated by the Corporation for the purpose of impounding and caring for amimals taken up by the agents of the Corporation in violation of the By-law.

At Large: - Any dog shall be deemed at large when he is off of the property of his owner and not under control of a competent person.

Exposed to Rabies: - An animal has been exposed to rabies within the meaning of this By-law if it has been bitten by any animal known or suspected of having been infected with rabies.

- 2. The provisions of this By-law shall be enforced by the Corporation, its servants, agents, workmen, employees or any-of them.
- No person shall own, keep, or harbor any dog within the Village limits of the Village of Cobden, unless such dog is licensed as herein provided From and after the passing of this By-law, 'effery owner of every dog in the Village of Cobden, shall, annually immediately following the first day of January and not later than the first day of February in every year, cause the same to be registered, numbered, described and licensed for a period of one year thereafter in the offices of the Willage of Cobden and shall cause the said dog when on and for off the premises of the owner thereof, but within the said Village to wear around its neck a collar, to which collar shall be attached a metallic plate having raised, cast or stamped thereon

figures indicating the year for which the said license has been paid, together with a number corresponding with the number under which the said dog is registered in the offices of the Village of Cobden and every such owner shall pay for such licence, metallic plate and registration, the sum hereinafter set out and every such license shall expire of the 31st day of December in each year next thereafter. Written application for licenses shall be made to the Village of Cobden, or such departments of the said Village as may be designated by the Council of the Corporation of the Village of Cobden. The application shall state the name and address of the owner, the name, breed, sex, color and age of the dog. The license fee shall be paid at the time of making the application, a numbered receipt given to the applicant and a numbered mettalic tag shall be issued to the owner.

(b) The yearly license fee for every dog licensed under the provisions of this By-law shall be as follows:

(i)	For a male dog if only one is kept,	\$ 3.00
	For each additional male dog,	5.00
(ii)	For a female dog if only one is kept,	6.00
	For each additional female dog,	10.00

Where the certificate of veterinarian surgeon is produced at the time of the application to license a dog, showing that a female dog has been spayed, it shall be taxed at the same rate as male dog.

In the event that the metallic tag shall become lost, the owner of the dog for which a tag was issued may obtain a duplicate tag upon the payment of a fee of \$1.00

- (c) Every person who owns, operates or conducts a kennel of pure bred dogs which are registered with the National Kennel Club pursuant to the Statutes of Ontariomenacted in that behalf, shall pay to the Town immediately following the first day of January in any year a tax or license of \$10.00, and in addition shall procure additionaltags from the Village for each dog over and above the number of five at a cost of \$1.00 per tag providing always that such tags will be for specified dogs and shall not be used in general from time to time on different dogs in such kennel.
- (d) If there is a change of ownership of a dog or kennel during the license year, the new owner may have the current license transferred to his name upon the payment of a transfer fee of \$1.00
- (e) No person shall use for any dog a license receipt, or a license tag issued for another dog.

1. Tag and Collar

- (a) Upon the compliance of the provisions of subsection (b) of Section 3 of this By-law, every owner of a dog, or dogs, shall be issued a numbered metallic tag, stamped with the year of issuance. The shape or design of such tag may be changed from year to year.
- (b) Every owner is required to see that the tag is securely fastened to the dog's collar or harness, which must be worn by the dog at all times.

5. Impoundment

Unlicensed dogs, or dogs and other animals found running at large, shall be taken up by the agents of the Corporation and impounded in the Village Dog Pound and there confined in a humane manner for a period of not less than two days and may thereafter be disposed of in a humane manner if not claimed by their owners. Dogs and cats not claimed by their owners at the expiration of two days, shall become the property of the Corporation and humanely disposed of by the Corporation, except as hereinafter provided in the cases of certain animals.

6. Restraint

The owner of any dog shall not permit such dog to run at large at any time during the months of March, April, May, June, July, August, September, October, November, in any of the Public parks, squares, drives, streets, lanes or other public place in the Village of Cobden, or upon any premises not owned or leased by the owner, unless such dog is accompaned by, and is under the immediate charge and control of some competent person, and such dog is at all times on a leash, and any dog found running at large, contrary to the provisions, will be liable to be captured and disposed of as herein provided.

- 7. The Corporation orits agents may transfer title to all animals coming into its possession as set forth in Section 5 of this By-law and may dispose of such animals at its descretion.
- 8. When dogs are found running at large and their ownership can be ascertained by the agents of the Corporation, such dogs need not be impounded, but the agent may, in his descretion, take the dogs to their owners, and may cite such offending owners for violations of the provisions of this By-law.
- 9. Immediately upon the impoundment of dogs orother animals, the agents of the Corporation shall make every possible effort to notify the owners of such dogs and other animals impounded, and inform such owners of the conditions whereby they may regain custody of the animals.
- 10. It shall be mandatory for the agent of the Corporation to cite into court the owner of any bitch who permits such bitch to be at large while in season or heat.
- When dogs or cats are impounded and are not claimed by their owners within the time specified by this By-law, if deemed suitable as pets, they may be placed with new owners who will agree to such conditions as the Corporation shall prescribe. Except, that no bitch or female cat shall be so placed with a new owner unless such new owner shall agree to have such bitch or female cat spayed.

12. Redemption of Impounded Animals

- (a) The owner shall be entitled to regain possession of any impounded dog except as hereinafter provided in the cases of certain dogs, upon compliant with the license provisions of Section 3 of this By-law and the payment of impoundment fees set forth herein.
- (b) Any other animal impounded under the provisions of thes By-law may be reclaimed by the owner upon the payment of impoundment fees set forth herein.
- (c) Any animal impounded under the provisions of the By-law and not reclaimed by its owner within two days, may be humanely destroyed by the corporation of placed in the custody of some person deemed to be a responsible and suitable owner, who will agree to comply with the provisions of this By-law and such other regulations as shall be fixed by the Corporation.

13. <u>Impounded Fees</u>

Any animal impounded hereunder may be reclaimed as herein provided upon payment by the owner to the Corporation of the sum of Three Dollars (\$3.00).for each dog, and the additional sum of Seventy-five Cents (0.75) for each day such dog is kept after the expiration of the legal detention period; One Dollar (\$1.00) for each cat and the additional sum of Fifty Cents (50%) for each day such cat is kept after the expiration of the legal detention period; and Five Dollars (\$5.00) for any other animal, exception rabbits, poultry and birds, and the additional sum of Two Dollars (2.00) for each day such animal is kept after the legal detention period. Impoundment fees as set forth herein and such additional sums as herein provided for keeping animals, shall be collected by the Corporation and retained by it to help the costs of keeping such animals beyond the period set forth herein.

14. Confinement of certain dogs and other animals

- (a) The owner shall confine within a building or secure enclosure, everyfierce, dangerous or vicious dog and not take such dog out of such building or secure encloure unless dog is securely muzzled.
- (b) Every female dog or cat in heat shall be kept confined in a building or secure enclosure, or in a veterinary hospital or boarding kennel, in such manner that such female cat or dog cannot come in contact with another animal, except for breeding purposes.
- (c) No wild animal may be kept within the Village limits, except under such conditions as shall be fixed by the Corporation. Provided, however, that wild animals may be kept for exhibition purposes by circuses, zoos and educational institutions, in accordance with such regulations as shall be established by the Corporation.
- (d) Any animal described in the foregoing subsection of Section 14, of this By-law, found at large, shall be impounded by the Corporation and hay not be redeemed by owners, unless such redemption be authorized by any Court having jurisdiction.
 - (e) Any, dog, cat or other animal, impounded for being a public nuisance may not be redeemed unless such redemption is authorized by any court having jurisdition.
 - (f) When in the judgment of the Corporation or its agents, an animal should be destroyed for humane reasons, such animal may not be redeemed.

15. Rabies Control

- (a) Every animal which bites a person shall be promptly reported to the Medical Officer of Health of the Corporation of the Village of Cobden or his authorized agent and shall thereupon be sucurely quarantined at the direction of the Medical Officer of Health or his authorized agent for a period of fourteen days, and shall not be released from such quarantine except by written permission of the Medical Officer of Health or his agent. In the discretion of the Medical Officer of Health or his agent, such quarantine may be on the premises of the owner, at the shelter designated as the Town Animal Shelter, or at the owner's option and expense, in a veterinary hospital of his choice. In the case of stray animals, or in the case of animals whose ownershop is not known, such quarantine shall be at the sholter designated as the Village Animal Shelter.
- (b) The owner upon demand made by the Corporation shall forthwish surrender any animal which has bitten a human, or which is suspected as having been exposed to rabies, for supervised quarantine which expense shall be borne by the owner, and may be reclaimed by the owner if adjudged free of rabies, upon payment of fees set forth in Section 13 of this By-law, and upon compliance with the licensing provisions set forth in Section 3 of this By-law.
- (c) When an animal under quarantine has been diagnosed as being rabid, or suspected by a licensed veterinarian as being rabid, and for where a report of a licensed veterinarian has given a positive diagnosis of rabies for such quarantined animal and such animal dies while under observation, the Reeve or Council of the Corporation of the Village of Cobden, on the recommendation of the Medical officer of Health, may declare that a Town-wide quarantine for a period of six months be imposed and upon the invoking of such quarantine by the Council, no animal shall be taken into the streets, or permitted to be in the streets, during such period of quarantine. During such quarantine no animal may be taken or shipped from the Town without written permission of the Corporation or its agents.
- (d) During such period of rabies quarantine as herein mentioned, every animal bitten by an animal adjudged to be rabid, shall be forthwith destroyed or at th owner's option and expense, shall be treated for rabies infection by a licensed veterinarian, or held under thirty days' quarantine in the same manner as othe animals are quarantined.

- (e) In the event there are additional positive cases of rabies occuring during the period of the quarantine, such period of quarantine may be extended for such additional period of time not exceeding six months, as the Council may deem advisable.
- (f) No person shall kill, or cause to be killed, any rabid animal; any animal suspected of having been exposed to rabies, or any animal biting a numan, except as herein provided, nor remove same from the Village limits without written permission from the Medical Officer of Health.
- (g) The carcass of any dead animal exposed to rabies shall upon demand be surrendered to the Corporation or its agents.
- (h) The Corporation or its agents shall direct the desposition of any animal found to be infected with rabies.
- (i) No person shall fail or refuse to surrender any animal for quarantine or destruction as required herein when demand is made therefor by the Corporation or its agents.

16. Reports of Bite Cases

It shall be the duty of every physician, or other practitioner, to report to the Corporation the names and addresses of persons treated for bites inflicted by animals, together with such other information as will be helpful in rabies control.

17. Responsibilities of Veterinarians

It shall be the duty of every licensed veterinarian to report to the Medical Officer of Health his diagnosis of any animal observed by him as a rabies suspect.

18. Exemptions

- (a) Hospitals, clinics and other premises operated by licensed veterinarians for the care and treatment of animals are exempt from the provisions of this By-law, except where such duties are expressly stated.
- (b) The licensing requirements of this By-law shall not apply to any dog belonging to a non-resident of the Village and kept within the Village for not longer than thirty days, provided such dags shall at all times while in the Village be kept within a building, or vehicle, or be under restraint by the owner.

19. Investigation

For the purpose of discharging the Buties imposed by this By-law and to enforce its provisions, any agent of the Corporation or any police officer, is empowered to enter upon any premises upon which a dog is kept or harbored and to demand the exhibition by the owner of such dog or the license of such dog. It is further provided that any agent of the Corporation may enter the premises where any animal is kept in a reportedly cruel or unhumane manner and demand to examine such animal and to take possession of such animal, when in his opinion, it required humane treatment.

20. Interference

No person shall interfere with, hinder or molest any agent of the Corporation in the performance of any duty of such agent, or seek to release any animal in the custody of the Corporation or its agents, except as herein provided.

21. (a) For the purpose of discharging the duties imposed by this By-law and to enforce its provisions, the Corporation shall engage the nedessary personnel, equipment, vehicles and facilities necessary to administenthe same.

- (b) The Corporation or its agents shall keep, or cause to be kept, accurate and detailed records of the licensing, impoundment and disposition of all animals coming into its custody.
- (c) The Corporation or its agents shall keep, or cause to be kept, accurate and detailed records of all bite cases reported to it, and its investigation of same.

22. Penalty

Any person or persons quilty of an infraction of any of the provisions of this By-law shall, upon conviction thereof before the Police Magistrate, or any Justice or Justices of the Peace in and for the Village of Cobden, forfeit and pay at the discretion of the said Police Magistrate, Justice or Justices convicting, a penalty not exceeding the sum of Fifty (\$50.00) Dollars for each offence, exclusive of costs (unless he shall have reclaimed and paid for such dog, as provided in Sections 5 and 13 of this By-law); and in default of payment thereof forthwith, it shall and may be lawful for the Police Magistrate or Justice or Justices convicting as foresaid to issue a warrant under his hand and Seal to levy such penalty and costs or costs only, by distress and sale of the offender's goods and chattels; and in case of no sufficient distress to satisfy the said penalty and costs, it shall be lawful for the Police Magistrate, Justice or Justices convicting as aforesaid to commit the offender or offenders to the common goal of the County of Renfrew with or without hard labour for any period not exceeding one calendar month, unless the said penalty and costs are sooner paid.

23. Repeals

All By-laws of the Corporation relating to the keeping, licensing, restraining and quarantine of dogs are hereby repealed.

24. Severability

If any part of this By-law shall be held void such part shall be deemed severable, and the invalidity thereof shall not affect the remaining parts of this By-law.

25. This By-law shall come into force and be effective from the 9th day of March, A. D. 1956.
