

VILLAGE OF COBDEN

BY-LAW NO. 1028.

A By-law to close part of Jason Street,
Village of Cobden.

WHEREAS the Municipal Council of the Village of Cobden deem advisable and in the public interest that part of Jason Street lying between Gould Street and Dixon Street in the said Village, be closed and stopped up, and the soil and freehold thereof sold.

AND WHEREAS due notice had been given by publication in the Cobden Sun, in the editions of that paper dated the 20th. day of June 1957, the day of 27th. June 1957, the 4th day of July 1957, and the 11th. day of July 1957, and at least six notices have been posted up for a full month or more in the vicinity of the said street so to be closed, all as required by law.

NOW THEREFORE BE IT ENACTED by the Municipal Council of The Corporation of the Village of Cobden, and it is hereby enacted as follows:-

1; That that part of Jason Street ^{PLAN 126} in the said Village of Cobden lying between Gould Street and Dixon Street, abutting lots numbered 100 and 512 on the south side and lots numbered 102 and 511 on the north side, be and the same is hereby closed and stopped up.

2; That the soil and freehold of the said street so to be closed and stopped up be sold for the sum of \$800.00.

3; This this by-law shall come into force and effect immediately on the final passing thereof.
