## THE CORPORATION OF THE VILLAGE OF COBDEN BY-LAW NO /050

A BY-LAW FOR THE SUBMISSION TO A VOT OF A QUESTION UNDER THE LIQUOR LICENCE ACT.

WHEREAS THE TIME OF THE COMING INTO FORSE OF THE ONTARIO

TEMPERANCE ACT A BY-LAW NO PASSED UNDER THE BIQUOR LICENCE

ACT WAS IN FORCE WITHIN THE LIMITS OF THE MUNICIPALITY PROHIBITING

THE SALE OF LIQUOR BY RETAIL THEREIN.

AND WHEREAS UNDER SECTION 69 AND 70 OF THE LIQUOR LICENCE ACT THE COUNCIL OF A MUNICIPALITY IN WHICH THE BY-LAW WAS IN FORCE MAY SUBMIT TO A VOTE OF THE PERSONS QUALIFIED TO BE ENTERED ON THE VOTERS LIST AND TO VOTE AT ELECTION TO THE ASSEMBLY IN THE MUNICIPALITY ANY QUESTION SET FORTH IN THE LIQUOR LICENCE ACT.

AND WHEREAS IT IS ALSO PROVIDED BY SECTION 69 AND 70 OF
THE ACT THAT WHERE A PETITION IN WRITING SIGNED BY AT LEAST
TWENTY-FIVE PER CENTUM OF THE TOTAL NUMBER OF PERSONS APPEARING
BY THE LAST REVISED LIST OF THE MUNICIPALITY TO BE RESIDENT
THEREIN AND QUALIFIED TO VOTE AT ELECTIONS TO THE ASSEMBLY
REQUESTING THE COUNCIL TO SUBMIT ANY QUESTION SET OUT IN
SECTION 69 AND 70 IS FILED WITH THW CLERK OF THE MUNICIPALITY
AND WITH THE BOARD, THE COUNCIL SHALL SUBMIT THE QUESTION TO

AND WHERAS A PETITION HAS BEEN FILED WITH THE CLERK OF THE MUNICIPALITY REQUESTING THE COUNCIL TO SUBMIT TO A VOTE OF THE PERSONS QUALIFIED TO VOTE THEREON THE FOLLOWING QUESTION.

ARE YOU IN FAVOUR OF THE ESTABLISHMENT OF GOKERNMENT STORES FOR THE SALE OF LIQUOR ?

AND WHEREAS THE PETITION CERTIFIED BY THE CLERK AS HAVING BEEN SUFFICIENTLY SIGNED HAS BEEN FILED WITH THE BOARD.

AND WHEREAS THE BOARD HAS FIXED WEDNESDAY THE TENTH DAY OF SEPTEMBER 1958, AS THE DAYUPON WHICH THE VOTE UPON THE QUESTION SHALL BE TAKEN AND HAS NOTIFIED THE CLERK TO THAT EFFECT.

AND WHEREAS THE COUNCIL DEEMS IT EXPEDIENT AND DESIRABLE THAT THE VOTE ON THE QUESTION SHALL BE TAKEN UPON THE DAY FIXED BY THE BOARD.

AND WHEREAS IT IS NECESSARY TO PROVIDE BY-LAW FOR THE SUBMISSION OF THE QUESTION TO THE PERSONS QUALIFIED TO VOTE THEREON AND FOR THE TAKING OF THEIR VOTES THEREON.

THEREFORE, THE COUNCIL OF THE CORPORATION OF THE VILLAGE OF COBDEN ENACTS AS FOLLOWS:

1. UNDER THE LIQUOR LICENCE ACT THERE IS HEREBY SUBMITTED
TO A VOTE OF THE PERSONS QUALIFIED TO BE ENTERED ON THE VOTERS
LIST TO VOTE AT ELECTIONS TO ASSEMBLY IN THE MUNICIPALITY
THE FOLLOWING QUESTION.

ARE YOU IN FACOUR OF THE ESTABLISHMENT OF GOVERNMENT STORES FOR THE SALE OF LIQUOR?

2. THE VOTE SHALL BE TAKEN ON WEDNESDAY THE TENTH DAY OF SEPTEMBER 1958, AS DIRECTED BY THE LIQUOR LICENCE BOARD OF ONTARIO AND IN ACCORDANCE WITH THE LIQUOR LICENCE ACT.
