Providing for the erection of Stop Signs at Intersections.

WHEREAS section 65(a) of the Highway Traffic Act R.S.O. 1960, Chapter 172) provides that the council of a municipality and the trustees of a police village may by by-law approved by the Department provide for the erection of stop signs at intersections on highways under its jurisdiction:

NOW THEREFORE the Council of the Corporation of the Municipality of Cobden enacts as follows:-

1. The intersections on highways under the jurisdiction of the Municipality of Cobden shown in Column below are designated as intersections where stop signs shall be erected at locations set out opposite thereto in Column 2:
