Being a by-law to amend by-law Mo. 1022, establishing an employment policy for the Corporation of the Village of Cobden,

- ARTICLE
- 1, Purpose of policy A. This by-law will define empolee status, rates of pay and hours of work.
 - B. This by-law will define the duties and responsibilities of labourers.
 - C. This by-law will define Holidays, Vacations and benefits.
 - D. This by-law will establish a complaint and grievance procedure.

ARTICLE

- 2, Empoyee Status
 - A. Men employed up to six months are deemed to be casual labourers.
 - B. Men employed for a period of six consecutive months or more are deemed to be permanent labourers (subject to ARTICLE 5 C.) unless specificaally exempted from this (5C) section by motion of Council.
 - C. Men who have been employed for a period of eighteen consecutive months or more are deemed to be skilled labourers.
 - D. At the end of six months consecutive employment a labourer will not be subject to summarydischarge (2B)

ARTICLE 3, Rates of Pay

- E. Overtime will be paid only at standard rates or in accordance with (4B)
- F. Pay period ending the fifteenth of the month will be paid on the nineteenth. Pay period ending at the end of the month will be paid on the fifth following.
- G. Trademen may be hired when necessary at their Prevailing rates.

ARTICLE 4, Hours of Work

- The work week will be $5\frac{1}{2}$ days of eight (8) Α. heurs each or forty four hours per week
- B, Overtime worked may be compensated for by taking equivalent time off at a time convenient to the employee and foreman and consistent with his duties.

ARTICLE 5, Duties and Responsibilities

- A. All labourers will be subject to the orders of the foreman regarding his work and will take their instructions from him, but if in his best judgment he feels he is being unfairly treated he has recourse to the grirvrnce Procedure below.
- B. Their duties will consist of any work appertaining to the efficient operation of the Corp. of the Village of Cobden, the Maintenance of syreets, the operation of the water and sewer systems, reading of hydro meters and for construction work where necessary.
- C. No man will be considered for permanent employment untilX he is capable of operating the water and sewer systems, he must be capable of doing this in the event of an emergency, during holidays and vacations of the foreman.

ARTICLE 6 Holidays, Vacations, Benefits.

. The following statutory holidays with pay may be taken subject to Article 4B, 58 & 6B.

- B. "Vacations with pay and hours of work Act " will apply for the first year of employment. EmployMEME ee will receive two weeks vacation with pay upon completion of two years of employment. Foreman and employee can not have the same time off for vacation or holidays, foreman will therefore have first choice.
- C. Sick leave with pay will be allowed at the rate of one day for every two months of employment after Sept. 1st, 1956.
- D. Sick leave may be accumulated up to a maximum of thenty four days.

ARTICLE 7 Grievance Procedure

- A. There will be a grievance committee of the Council set up each year, it will be composed of at least two councillors.
- B. The members of this commettee may be approached at any reasonable time with any problem that an employee may have. The members of the commettee will attemt to find an answer.
- C. Failing an understanding, the commettee will then bring the matter to the next regular meeting of council.
- D. If the decision of Council is unsatisfactory to the employee he may notify the Reeve of this fact and the Reeve will call a special meeting of Council at which the employee may present his case.
