BY-LAW NO. 1279

A by-law to co-operate with Pembroke and Renfrew in the engaging an Animal Control Officer (dog catcher) to supervise the three Municipalities.

BE IT ENACTED and it is hereby enacted that the Corporation of the Village of Cobden unitewith the Town of Pembroke and the Town of Renfrew and hire an Animal Contror Officer to serve the three Municipalities.

The remuneration and expenses to be devided on a pro-rata basis with Cobden Share \$ 200.00.

WHEREAS Pembroke, Renfrew and Cobden have enacted animal control by-laws within each Municipality.

AND WHEREAS Pembroke, Renfrew and Cobden have agreed to hire a joint animal control officer.

THEREFORE this Agreement witnesseth that in consideration of the premises the Parties hereto mutually covenant and agree each with the other as follows:

- (1) Pembroke shall hire an animal control officer and shall pay all of the expenses in connection therewith.
- (2) Pembroke, Renfrew and Cobden shall share the expenses of the animal control officer in each year in the ratio the population figures, according to the last revised assessment roll for that year, bear to the said expenses.
- (3) Renfrew shall provide for the proper disposal of animals from within its own boundaries.
- (4) Pembroke shall provide for the proper disposal of animals from within its own boundaries and that of Cobden.
- (5) Proper liability insurance shall be carried by the animal control officer.
- (6) Each municipality shall indemnify and save each other harmless from any act of the animal control officer as a result of his operations in one of the municipalities.

(7) The animal control officer, when operating in a municipality, shall abide by the animal control by-law in force in that municipality.
