

MUNICIPALITY OF VILLAGE OF COBDEN

BY-LAW NUMBER 1293

RESTRICTING THE SPEED
OF MOTOR VEHICLES

WHEREAS subsection 2 of section 59 of The Highway Traffic Act (R.S.O. 1960, Chapter 172) authorizes the council of a city, town or village and the trustees of a police village by by-law to prescribe a speed limit of 25 miles per hour for motor vehicles driven on any highway or portion of highway under its jurisdiction;

AND WHEREAS it is deemed expedient that the speed of motor vehicles on certain highways in the Municipality of Cobden be restricted;

NOW THEREFORE the Council of the Corporation of the Municipality of Cobden enacts as follows:

1. When any Highway or portion of highway set out below is marked in compliance with the regulations under The Highway Traffic Act, the maximum rate of speed thereon shall be 25 miles per hour.

John Street	Boundary Road	Mobton Street
Crawford Street	Boundary Road	Cowley Street
Gould Street	Boundary Road	Cowley Street
Cowley Street	Highway 17	Crawford Street
Boundary Road	Highway 17	John Street

2. The penalties provided in subsection 12 of section 59 of The Highway Traffic Act shall apply to offences against this by-law.
3. This by-law shall not become effective until approved by the Department of Transport.




