BY-LAW NO. 1405

Being a by-law to adopt all the estimates of all sums required during the year 1970, and to strike the rates of taxation for the year 1970

WHEREAS the Council of the Corporation of the Village of Cobden has in accordance with the Municipal Act considered the estimates of the Municipality and of the Boards and Commissions of the Municipality and it is necessary that the following sums be raised by means of tax--ation for the year 1970.

AND WHEREAS the Assessment roll made in 1969 and upon which the 1970 taxes are to be levied was finally revised by the court of revision.

AND WHEREAS the amount of assessment entitled to benefit, hereinafter referred to as residential and farm, and the amount of assessment not entitled to benefit, hereinafter referred to as commercial and business from unconditional grants in accordance with sections 294 and 297 of the Municipal Act, is as follows:

THEREFORE the Council of the Corporation of the Village of CobdenENACTS AS FOLLOWS:

1. That the estimates be adopted and the following amounts be levied therefore in the manner as set out hereinafter-

There shall be levied and collected upon the assessable lands, buildings and businesses within the Corporation of the Village of Cobden, the following rates for the year 1970.

The taxes shall become due and payable on the First day of July 1970, but may be paid in two (2) installments on the 15th day July, 1970, and the 15th day of December 1970.

- 4. There shall be imposed a penalty for nonpayment of taxes on due date or any installment thereof, the amount of 1% of the amount due and unpaid on the first day of default, and an additional penalty of 1% shall be added on the first day of each calendar month thereafter in which default continues, but not after the end of the year in which the taxes are levied.
- 5. There shall be allowed a discount of 6% per annum on any taxes so parid in advance of the 15th day of December during the current year.
- 6. The collector is hereby authorized to mail or caused to be mailed the notice of taxes due to the address of the residence or place of business of the person to whom notice is required to be given.
- 7. All taxes shall be paid into the office of the Treasurer or the Bank of Nova Scotia, Cobden, Ontario.
- 8. Where a tenant of lands, owned by the Crown or in which the Crown has an interest, has been employed either within or outside the Municipality by the same employer for not less than 30 days, such employer shall pay over to the collector on demand out of any wages, salaries, or other remuneration due to such employee the amount then payable for taxes under this by-law and such payment shall relieve the employer from any liability to the employee for the amount paid.
- 9. The collector and Treasurer are hereby empowered to accept partpayment from time to time on account of any taxes due.

10. This by-law shall come into force and effect upon the date of the final reading thereof.
