BY-LAW NO. 75-15 OF THE CORPORATION OF THE VILLAGE OF COBDEN

BEING A BY-LAW WITH RESPECT TO A WATER RATE UNDER SECTIONS 18 AND 56 (5) OF THE ONTARIO WATER RESOURCES ACT.

WHEREAS the Corporation of the Village of Cobden has entered into or proposes to enter into an agreement with Her Majesty the Queen in right of Ontario as represented by the Minister of the Environment for the supplying of water to the Municipality.

NOW THEREFORE the Council of the Corporation of the Village of Cobden ENACTS AS FOLLOWS:

- 1. A water rate is hereby imposed upon the owners or occupants of lands which are supplied with water as a consequence of the entering into of the abovementioned agreement by the Corporation of the Village of Cobden.
- 2. The water rate shall be a flat rate of \$72.12 per annum against each user in respect of such lands which are used for other than commercial or industrial purposes or as a service rate of 1.20¢/1,000 gallons of metered water consumption against each user in respect of such lands which are used for other than domestic purposes or as a flat rate as designated in schedule against users other than domestic users.
- 3. The flat rate designated in Paragraph 2 shall be billed and collected as a part of the charge for water to each user.
- 4. This By-law rescinds By-law Nos. 75-10 and 74-10.
- 5. This By-law is subject to the approval of the Ontario Municipal Board.

READ A FIRST AND SECOND TIME on the 17TH day of JUNE A.D. 1975.

READ A THIRD TIME AND FINALLY PASSED ON THE 17 TH day of JUNE A.D. 1975.
