CORPORATION OF THE VILLAGE OF COBDEN

BEING A BYLAW TO APPLY FOR GRANTS FOR THE INSTALLATION OF  
ARTIFICIAL ICE, ETC. (PHASE II) AT THE ASTROLABE ARENA.

IT IS HEREBY ENACTED AS FOLLOWS:


