Being a By-Law to authorize the Reeve and Clerk to execute a recycling agreement with Beaumen Industries for the provision of recycling services.


W H E R E A S paragraph 83 of Secion 210 of the Municipal Act, R.S.O. 1980, Chapter 302, authorizes Councils of local municipalities to pass by-laws for establishing and maintaining a system for the collection, removal, and disposal of ashes, garbage, and other refuse and for contracting for collection, removal and disposal of ashes, garbage and other refuse upon such terms and conditions as may be considered expedient; and


W H E R E A S Council deems it to be expedient and in the public interest to enter into an agreement with Beaumen Industries for the provision of recycling services.

N O W T H E R E F O R E the Council of the Corporation of the Village of Cobden enacts as follows:

1. THAT the Reeve and Clerk be, and hereby are, authorized to execute on behalf of the Corporation, the contract hereto annexed as Appendix 'A' with Beaumen Industries which said contract is hereby adopted as part of this by-law.
2. THAT the Reeve and Clerk be, and hereby are, authorized to do or to cause to be done all such manner of act of thing as may be required to give full force and effect to this by-law.
3. THAT this by-law shall come into force and effect upon the signing of this by-law.


W H E R E A S Council deems it to be expedient and in the public interest to enter into an agreement with Beaumen Industries for the provision of recycling services.


