BY-LAW # 1992-21

Being a by-law to acquire certain lands from George Wallace and Bertha Wallace

WHEREAS the easement for drainage as described in Schedule "B", By-law No. 1992-16, has been changed and it is necessary to revoke By-law No. 1992-165 for the purpose of enacting a new By-law to describe the said easement, as changed.

NOW THEREFORE be it enacted and it is hereby enacted as follows:

- 1. That By 1 aw No. 1992-16 be and it is hereby revoked in its entirety.
- 2. That in the place and stead of the By-law so revoked, be it enacted as follows:
 - (a) That the lands described in Schedule "A" hereunder be acquired from George Wallace and Bertha Wallace for street purposes.
 - (b) That the easement described in Schedule "B" hereunder be acquired from George Wallace and Bertha Wallace for drainage purposes.
 - (c) That the law firm of McNab, Stewart & Prince take all steps and do all things necessary to obtain and register good title in the name of The Corporation of the Village of Cobden to the said lands and easement.

SCHEDULE "A"

In the Village of Cobden, County of Renfrew, being part of Block "D", Registered Plan 65, being Part 1, Plan deposited as No. 49R-11124. Together with Water Line and Hydrant already installed in said Part 1.

SCHEDULE "B"

In the Village of Cobden, County of Renfrew, composed of Parts 2, 3 and 4, Plan 49R-11124.
