

# **CORPORATION OF THE VILLAGE OF COBDEN**

## **BY-LAW # 1997-11**

**BEING** a by-law to provide for the naming and renaming of the highways, streets, roads and private roads within the Village of Cobden.

**WHEREAS** Section 210(111) of the Municipal Act R.S.O., 1990, Chapter M45, authorizes the Councils of local municipalities to pass by-laws giving names to or changing the names of highways, and for affixing the names at the corners thereof, on public or private property;

**AND WHEREAS** Section 210(111a) of the Municipal Act R.S.O., 1990, Chapter M45, provides that a by-law to change the name of a highway has no effect unless a copy of it, certified under the hand of the clerk and the seal of the Corporation, has been registered in the property Land Registry Office;

**AND WHEREAS** Section 210(111b) of the Municipal Act R.S.O., 1990, Chapter M45, provides that before a by-law is passed to change the name of a highway, notice of the proposed by-law shall be published at least once a week for four successive weeks in a newspaper having general circulation in the municipality, and the Council shall hear any person who claims to be adversely affected by the by-law and who applies to be heard;

**AND WHEREAS** the Council of the Corporation of the Village of Cobden has caused a notice of the proposed by-law to be published, and at a meeting held on August 12, 1997 has heard any person who claims to be adversely affected by the by-law;

**WHEREAS** Section 210(113) of the Municipal Act R.S.O., 1990, Chapter M45, authorizes the Councils of local municipalities to pass by-laws for keeping a record of highways;

**NOW THEREFORE COUNCIL FOR THE CORPORATION OF THE VILLAGE OF COBDEN ENACTS AS FOLLOWS:**

### **Short Title**

1. This by-law may be cited as the "Road Naming By-law" of the Corporation of the Village of Cobden (the Municipality).

### **Naming of Highways/Streets/Roads**

2. All highways/streets/roads in the Municipality shall be named and/or known according to Schedule "A" attached to this By-law, as illustrated on Schedule "B" attached hereto.
3. Schedules "A" and "B" attached hereto form part of this by-law.
4. The Municipality is hereby authorized to affix street name signs at the corners of every highway/street/road, on public or private property, subject to the jurisdictions and the requirements of the County or the Ministry of Transportation.
5. All road name signs at intersections shall include the approved road name. Where new signs are to be erected, the sign shall include the approved road name and the direction and sequencing of property numbering.
6. Should any section, clause or provision in this By-law held to be invalid by a court of competent jurisdiction, the remainder of this By-law shall not be affected.

7. Any by-law or parts of by-laws inconsistent with this By-law, or names of streets in registered plans inconsistent with this By-law, are hereby deemed repealed.
8. This By-law shall come into full force and effect when a copy of it, certified under the hand of the Clerk and the seal of the Corporation, has been registered in the proper Land Registry Office.
