Moved by Saml Cooke that the road commissioner be instructed to give out a job of a bridge across water creek on the Belmer road as soon as possible
Mr Graff seconded Carried

Moved by Mr Murdock that this council grant the sum of \$15 ~~for~~ for the purpose of making a road at or near James Potts
Carried

Mr Cook gives notice that he will bring up a bylaw at the next meeting of council for the purpose of closing that part of the old Osceola road running through lot 2 on the first concession of Ross and of Muskat Lake
Carried

Moved by Mr Cooke seconded by Robert Murdock that this council grant twenty dollars on Joulds petition
Carried

Moved by Mr Cook seconded by Mr Graff that this council grant six dollars to be expended between James Ferguson and George Churches
Carried

Moved by John Graff and seconded by John Cartman that Emmanuel Lander receive an order on the treasurer for the sum of ^{for repairing road} 50 Cents
Carried

Moved by Mr Cooke seconded by Mr Murdock that and order be drawn in favor of John Marshall for the sum of \$3.14 for stationery supplied
Carried

Moved by Mr Cartman seconded by Mr Murdock that the pathmaster be instructed to turn the water in James Marshall's Creek into its natural course and road brought in to road allowance
Carried

Moved by Mr Graff seconded by Mr Cartman that Thomas Deacon receive an order on the treasurer for the sum of \$100 being for legal advice Carried

Moved by Mr Cook and seconded by Mr Murdock that the surveyor be appointed to run the blank alternate concession line between the third and fourth concessions from the proving line between lots 15 and 16 when he runs a line for a new road through Mr Marks and Mr Bulmers place near the government road Carried

Moved by Mr Murdock seconded by Mr Cooke that \$112.00 be struck of John Delahays assessment on personal property Carried

Moved by Mr Murdock seconded by Mr Cook that Robert Bulmers offer be accepted by this Council at \$30.00 for road allowance Carried

Moved by Mr Cartman seconded by Mr Murdock that John Delahay receive an order on the treasurer for the sum of \$125 for lumber for screening the hall Carried

Moved by Mr Graff and seconded by Mr Cook that Charles Goulter receive an order on the treasurer for the sum of \$5.00 for travelling on Township business Carried

Moved by Mr John Graff seconded Mr Cartman that Michael Gormandeur be allowed to remove the old road to the side line between lots nos 22 + 23 a he clears the land from the blank line between 4 and five and six to the line between 4 + 5 the old road not stopped until new one is made passable Carried

Moved by Mr Graff and seconded by Mr Cartman that the road commissioner be authorized to let the job at James Perros Carried

Moved by Mr Murdock seconded by Mr Cooke
that the road commissioner be instructed to
give out a job of carrying a small bridge
near Emmanuel Sanders on government-road
Carried

Moved by Mr Cartman seconded by Mr Fraff
that the road commissioner be instructed
to let the road job railing cartman by
jully bridge on the queens road Carried

Moved by Mr Murdock seconded by Mr
Cook that the sum of two dollars \$2.00 be
expended on the bridge known as jilmors
bridge on the queens road and that
the road commissioner expend the same
Carried

Moved by Mr Murdock and seconded by Mr Fraff
that the reeve and treasurer be employed by
this council to go to pembroke and take legal
advice on Mr J. A. Burritt's claim against
the corporation of Ross also to investigate
into the matter regarding the lot being numbered
wrong the lot no 21/13 in the 4th division
of Ross

that this council do now adjourn till
to the last day Saturday in August
at 8 o'clock at the home of Tinselock Carried
