Moved by Mr Cook seconded by Mr Murdoch that an order be drawn in favour of James M. Cagherly for the sum of \$6.⁰⁰ for paying James Allan R.L.S. for running a line between the 3rd and 4th concessions of Ross. Carried.

Moved by Mr Cook seconded by Mr Graff that this Council grant Robert Murdoch \$3.³⁰ for finding the Surveyor in error in the survey of the Bulmer Road. Carried.

Moved by Mr Graff seconded by Mr Cartman that this Council do now adjourn to meet again on the first Saturday in October next in Cobden. Carried.

Town Hall Cobden October 4th 1879

Pursuant to adjournment the Municipal Council of the Township of Ross met in the Town Hall Cobden on the aforesaid date. Members all present except Mr Cook. The Revere presiding.

Minutes of former meeting were read approved of and signed by the Revere & Clerk.

Moved by Mr Murdoch seconded by Mr Graff that John Hill (Clerk) receive an order on the Treasurer for the sum of \$2.⁰⁰ for work done on roads. Carried.

Moved by Mr Murdoch seconded by Mr Graff that Edward Tuffey receive an order on the Treasurer for the sum of seven dollars for work done on Tuffys Hill. Carried.

Moved by Mr Muddock Secouded by Mr Graft that Bylaw No 6 for the purpose of opening up the Road known as the Bulmer Road on lots 10 & 11 in the 9th Concession of the Township of Ross be brought up and read the first time. Carried

Moved by Mr Muddock Secouded by Mr Graft that Bylaw No 6 for the purpose of opening up a road on lots No 10 & 11 in the 9th Concession of the Sp. of Ross be now brought up and read the first time Secoud & third time Short & passed. Carried

Moved by Mr Muddock Secouded by Mr Cartman that Bylaw No 7 for the purpose of closing up the old Oscoda Road in the Township of Ross be now brought up and read the first time. Carried

Moved by Mr Graft Secouded by Mr Muddock that Bylaw No 7 for the purpose of closing up the old Oscoda Road in the Sp. of Ross be now brought up and read the first time Secoud and third time Short and passed. Carried

Moved by Mr Graft Secouded by Mr Muddock that the Road Commissioner be instructed to let the job of making a piece of Road on the fourth Concession of Ross on lots nos 11 & 12 and not to exceed more than \$25.00 Carried

Moved by Mr Graft Secouded by Mr Muddock that this Corporation grant the sum of \$20.00 for the purpose of draining Main Street Cobden. Carried

Moved by Mr Graft Secouded by Mr Cartman that this Council do now adjourn to meet again on the first Saturday in November 1879. Carried
