

Town Hall, Cobden

26th May 1894

The Municipal Council of the Township of Ross met in the Town Hall, on the 26th May 1894 as a Court of Revision. The Reeve in the Chair. All the members present, and took the oath of Office required by Law.

Moved by Mrs Bell, & second by Mr Rose that Lot No. 11th in the pt. Con. be changed from Edward G. Lee to Henry Behm. Carried.

There being no appeals against the Assessment,

It was moved by Mr McLaren & second by Mr Bulmer, that the Roll be accepted & confirmed, and that the Court do now adjourn. Carried.

The Council now took up the general business of the Township.

Minutes of previous meeting read & confirmed.

Mr Bulmer gives notice that he will at this present meeting of Council introduce a By Law for the payment of moneys.

Moved by Mr Bulmer and seconded by Mr McLaren, that a grant of \$50⁰⁰ be made to improve the pt. Con. Line, from Mrs Coles to Prov. Line. Carried.

Moved by Mrs Bell & second by Mr Rose, that an order be granted on the Treasurer in favor of Samuel Pickett for two dollars, being for Road work performed & charged in Taxes. Carried.

Moved by Mr. Bulmer & Sec by Mr. Rose That an order be granted on the Treas to the following parties for the amount set opposite their names respectively

 the Hill near Mr. Jamison's Lime Kiln. Cost
 not to exceed \$50.00 Carried.

Mr. Hamilton Pathmaster having left the Township
 Mr. Bulmer Moved Sec by Mr. Bell That
 Walter Bruce be appointed in his place. Carried.

Moved by Mr. Bulmer & Sec by Mr. Bell.
 That Chas. G. Coulter purchase 1000 feet plank
 to repair old side walk, & build new one from
 end of McHaren to Bromley St. Carried.

Moved by Mr. Bulmer & Sec by Mr. McHaren, That
 Mr. Bell have the 3rd Con. Line, from South Line to Mr
 Neils' Creek, opened out to make it possible for
 a winter road. at a cost not exceeding \$35.00
 Carried.

Moved by Mr Bulmer & Secd by Mr McLaren
That John Rose have the 4th Con. Line Road
repaired from joining line between lots 20 & 21.
towards Hay Road. Cost not to exceed \$15⁰⁰/₁₀₀ —

Carried.
Moved by Mr Bell & Secd by Mr McLaren
That a grant of \$50⁰⁰/₁₀₀ be made to make
a road around Hill on fence road ac-
cross Lorenzo Brown's farm, and that
Mr. Bulmer give out the job. Carried.

Moved by Mr Bulmer & Secd by Mr Bell,
That Mr Tripp have Bridge on Kov. line near
Mr. Wm McLaren repaired at a cost not
exceeding \$20⁰⁰/₁₀₀ Carried.

Moved by Mr Bell & Secd by Mr Bulmer, That
the Council do grant the sum of \$25⁰⁰/₁₀₀
provided Westmeath Council do make an equal
grant towards repairing Leen line between
Ross & Westmeath, from Musk-Rat-hake
to John Collins, and that Munro Ross
along with the Road Com. of Westmeath give
out the job. Carried.

Moved by Mr Bell Secd by Mr Ross That Elias
McLade jr. Pathmaster be instructed to have
Thos Gibson Sr. Thos Gibson jr. & Sam. Gibson
to do their Road work in building approach
to Bridge across Neils Creek. Carried.

Moved by Mr Bulmer & Secd by Mr Bell,
That By Law No. 104 for the payment of moneys
be now brought up and read a first time.

Carried.
Moved by Mr Ross & Secd by Mr Bell That a grant of \$30⁰⁰/₁₀₀
be made to repair the Road near Mr Pevers and that
Mr. Bulmer give out the job. Carried.

Moved by Mr Bulmer & Sec'd by Mr Rose
That By Law No. 104, be filled in with
the amounts granted by Council and then
brought-up and read a second time.
Carried.

On Motion of Mr Bulmer & seconded by
Mr Bell By Law No. 104, was now brought-
up and read a third time & passed.

Moved by Mr. McHaren & Sec'd by Mr. Bell
That this Council do adjourn to meet again
on the 1st Saturday in July next.
Carried.
