The Municipal Council of the Township of Ross met in the Town Hall, Cobden on the above date for the transaction of the general business of the Township. The Mayor in the Chair. Councillors all present. Minutes of previous meeting read & confirmed.

Moved by Mr Reynolds & Seconded by Mr Crozier, that the sum of \$15.00 be granted to Abraham Shroeder, to be expended as follows, \$10.00 to repair Hill opposite Lot-10, Con. 12, and \$5.00 to repair road to Parsons Bay. Carried.

Moved by Mr McLaren & Seconded by Mr Palmer, that Mr John Faught be allowed his statute labor, for the putting in of a Culvert opposite his gate. Carried.

Moved by Mr McLaren & Seconded by Mr Reynolds, that Mr C. G. Leutter be allowed to purchase 1200 feet of 2 inch plank, to repair Culvert at Railway track, & cover side walk from R. Street to the Residence of Mr McKellops. The Council paying for the plank. Carried.

Mr McLaren gives notice that he will at this present meeting of Council introduce a By-law for the payment of Moneys. Carried.

Moved by Mr. W. L. Loran & Second by Mr. Crozier. That By Law No. 115 for the payment of moneys, to now brought up and read first time

Moved by Mr. Reynolds & Seconded by Mr. W. L. Loran, That Mr. R. W. Ross, be allowed two years Statute Labor for opening up drain off Spruce lot. 8. to Mr. Joseph Bennett July

Moved by Mr. Crozier & Seconded by Mr. Bulmer. That the sum of \$25.00 be granted to Mr. David Cooke to expend on 4th Con. Lane off Spruce lots 18 & 19.

On Motion of Mr. W. L. Loran Seconded by Mr. Bulmer By Law No. 115 - was now brought up and read a ~~second~~ <sup>third</sup> time short & passed.

Moved by Mr. Crozier & Second by Mr. W. L. Loran. That \$12.00 be granted to Mr. Gould for road allowance on lot no. 5. The said Road to be 40 feet wide

Moved by Mr. W. L. Loran & Seconded by Mr. Bulmer That the Council as a Body examine Crossing at Ostrander's Lake for the purpose of having a Bridge built across the same.
