along Muskrat-Lake Road, to proper distance
from Center of Road, from Cobden to
Town line between Ross & ~~Ross~~, Westman, Carried.

Moved by Mr. Reynolds & Sec'd by Mr. Crozier
That the Clerk instruct the Road Commission
to inspect & let Contract, if necessary, of
repairing Bridge opposite lot-11, Con. 9, also
Bridge on Road between lots 16 & 17, Con. 2,
to give out job of stumping on line between
Con. 7 & 8 extending from Town line to Center
of lot-2. Carried.

The Clerk having presented what
Legal advice he obtained in regard to the
By-law forbidding the running at large of
Cattle &c in village of Cobden.

On motion of Mr. Reynolds seconded by Mr.
Crozier, this Council does not feel inclined
to take any action on the passing of the said
By-law.

On motion of Mr. Ross seconded
by Mr. Humphries, the Auditors report
was adopted.
