Moved by Messrs McLaren and Jeffery that this Council donate \$5⁰⁰ to Allen McNabb. Carried.

Moved by Messrs Jeffery and McLaren that Bylaw No 189 for the payment of moneys be now introduced and read a first time. Carried.
